RULES

- Pre-registration is required to participate in this event.
- Categories: adult (age 18 & up), Child (ages 8-17 years), Group/Family (3 or more people submitting one structure)
- The base of the gingerbread house shall be a **maximum** of 36"x 36". All entries shall be on a rigid base, such as plywood.
- Structure must consist mainly of gingerbread and icing. Non-visible interior supports of other materials are allowed. The entire visual display is to be made of edible materials. For example, if wrapped candies are used, they must first be removed from the wrappers.
- Entries must be original. No kits allowed.
- Ribbons will be awarded as follows: one Overall Winner; 1st, 2nd & 3rd place in each category, and one People's Choice Winner. Judging will take place at 2:30pm; ribbons will be awarded at 5:30pm.
- The Monmouth County Park System reserves the right to cancel the event in the case of severe inclement weather. If that should happen, a full refund will be given; however, our events usually take
