PRESENTATION:

Andrew Spears, Assistant Director, and Gail Hunton, Chief of Acquisition & Design, reviewed with the Board the proposed 2017 Capital Budget.

Andrew Spears, Assistant Director, reviewed with the Board the background on our Capital Budget Program.

Commissioner Harmon asked what the difference was between the Regular Capital Budget and the Special Appropriation.

Andrew Spears explained that the Special Appropriation request is part of a six (6) year plan, for projects of a larger scope, above and beyond the Regular Annual Capital Request.

Gail Hunton, Chief of Acquisition & Design, reviewed with the Board each project in the 2017 Program.

Commissioner Peters asked what the revenue of the Creative Arts Center is.

Patti Conroy, Superintendent of Recreation, replied that it is in the top three of revenue performers of all Visitor Services areas.

Commissioner Butch asked about the Deep Cut Gardens wall.

Gail Hunton said that the repair contract has been awarded but work has not yet begun.

Commissioner Butch inquired about the capacity of the proposed composting toilet at Clayton Park.

Gail Hunton said that she would find out the answer and get back to the Board.

Commissioner Harmon asked if there were other composting toilets in use in our area.

Gail Hunton said that staff looked at a similar one at Duke Farms in Somerset County.

Freeholder Lillian G. Burry noted that Big Brook Park's former YMCA Arrowhead site is a great property with a lot of potential.

Freeholder Burry asked about the expansion of parking at Fort Monmouth.

Andrew Spears explained that roadside parking will be expanded and the lot next to the former service station re-configured.

Commissioner Harmon asked about the living shoreline portion of the Claypit Creek project. He noted that the shoreline section in question is less than 900', as was indicated in the project sheet.

Commissioner Harmon asked if there were local examples of the concept for the Portland Place slope stabilization.

Gail Hunton showed the Board a photo of a non-local example.

Commissioner Butch asked if the Board could see the concept plan for Portland Place Shoreline Stabilization once it is developed.

Commissioner Butch remarked about the proposed Charleston Springs pond dredging and repairs.

Commissioner Butch emphasized the importance of making trail connections through Charleston Springs with existing trails on adjoining properties.

Commissioner Harmon asked about parking at Fisherman's Cove and our Agreement with the Borough of Manasquan.

Tom Fobes explained the agreement.

Commissioner Harmon stressed the importance of starting the process now for getting permitting and state support for dredging of the channel at Swimming River Park.

Gail Hunton concluded her presentation and thanked the Board for their support.

FREEHOLDER'S REPORT:

Freeholder Lillian G. Burry commended the recent graduates of the 30th County Park Rangers Training Class and said she enjoyed addressing the new rangers at the ceremony.

Freeholder Burry noted that Rangers are the face of the Park System.

Freeholder Burry also commented on the recent Master Gardener Graduation that she and Tom Fobes attended.

Freeholder Burry thanked Gail Hunton for drafting the text that will appear on an historic plaque at Hominy Hill, to be erected by the Colts Neck Historical Preservation Committee.
