Chairman Rummel led the Board in the salute to the flag and the Pledge of Allegiance and asked for the observance of a moment of silence.

At 7:04 PM, Vice Chairman Mandeville arrived at the meeting.

On a motion made by Commissioner Horsnall, seconded by Commissioner Adcock, the MINUTES of the REGULAR MEETING of the Monmouth County Board of Recreation Commissioners held on MONDAY EVENING, NOVEMBER 20, 2017, were upon being put to a vote, approved as recorded by Chairman Rummel, Vice Chairman Mandeville, Commissioners Harmon, Horsnall, Butch and Adcock. Commissioner Hennessy abstained as not being present at the meeting.

Commissioner Hennessy abstained as not being present at the meeting.

The Secretary-Director indicated that the Minutes of the Executive Session would be made available to the public in ninety (90) days, or upon completion of land acquisition matters.

On a motion made by Commissioner Hennessy, seconded by Commissioner Adcock, the meeting was **OPENED** to the **HEARING OF THE PUBLIC** at 7:05 PM. Upon being put to a vote, the motion was unanimously carried.

There being no one present to be heard, it was moved by Vice Chairman Mandeville, seconded by Commissioner Hennessy, that the portion of the meeting **OPEN** to the **HEARING OF THE PUBLIC** be **CLOSED**, at 7:06 PM.

SECRETARY-DIRECTOR'S REPORT:

James J. Truncer, Secretary-Director, introduced staff who made the following **Presentations** to the Board:

1. <u>Visitor Services Report</u>

Patti Conroy, Superintendent of Recreation, made a power point presentation to the Board showing the following:

- Semi-Formal held on November 3rd, with 46 people attending;
- Fall Craft Show held on November 11th, with 52 Vendors and 925 Visitors;

- Trails Team Hartshorne Woods November 18th;
- Dune Planting at Seven Presidents Oceanfront Park on November 19th:
 - 4 Trails Team Crew Leaders; and
 - 22 Volunteers planting 4,000 plants.
- Each year Therapeutic Recreation goes to Disney on Ice the Wednesday before Thanksgiving;
- Inflation Eve trip to see the balloons inflated for the parade which is always popular and sells out;
- Jolly Jingle Jamboree held on December 2nd, with 62 participants craft, food project, story time with Mrs. Claus, and photos with Santa;
- Coming Soon! CAC Holiday Party on December 9th, from 12:30 PM to 2:30 PM; and
- Pilot Study with Rutgers on the effects of Equine-Assisted Activities & Therapies on the well-being of Veterans with PTSD.

Mrs. Conroy shared a story about Paul Drew from the Horses to Heroes program. Paul Drew is new in our Horses for Heroes program. His family is from Virginia and was in town to spend Thanksgiving with him. They all came by a few days after Thanksgiving. One of his relatives took Lisa aside and said that he is a different person since he started the Horses for Heroes program at Sunnyside. She has been spending Thanksgiving with him for 25 years and he barely ever speaks. She said this year he never stopped talking about Gracie (the horse he has been working with) and about Sunnyside. He brought the family up to see the horses and meet Gracie. She stated that it has changed his life!

We are so fortunate that we are able to offer these programs that impact peoples' lives for the better. We can all be proud!

2. Golf Report

Mike Janoski, County Park Superintendent/Golf Operations, reported to the Board that golf rounds in November were down 2,069 as compared to November 2016, and noted that this is attributed to colder weather in 2017. Mr. Janoski distributed a copy of the November 2017 golf rounds report to the Board.

Mr. Janoski also reported that 22 golfers competed in the "Beat the Feast" shotgun event held at Howell Park Golf Course on Thanksgiving morning.

Mr. Janoski reported to the Board that year to date total golf rounds are now down slightly at 593 rounds (209,849 versus 210,442).

Mr. Janoski also reported that through October 31, revenues were up 3.7% at over \$9.4 million.

Mr. Janoski reported to the Board that the crew at Shark River Park Golf Course continues with their in-house master plan improvements recently completing two (2) new tees on the 11th hole. They have now begun a new ladies tee on hole 14 as we continue to make the course friendlier for senior and ladies.

Mr. Janoski also reported that many of our Golf Course Superintendents will be attending the NJ Turfgrass Expo this week in Atlantic City, NJ.

3. Parks Report

Tom Fobes, Superintendent of County Parks/Park Operations, reported to the Board on park operations for the month of November. Mr. Fobes reported that Monmouth County Park Rangers just completed this seasons mowing cycle, and are continuing to remove leaves, debris, and clean out gutters and storm drains.

Mr. Fobes reported to the Board that winter preparations that are underway. Park staff has removed fire pumps from our pickup trucks, and are winterizing summer equipment, mowers, blowers, edgers, weed eaters, so on and so forth. The majority of this work is completed by Park Rangers at their park maintenance facilities – cleaning and steam cleaning, greasing, removing fuel or adding fuel additives. Park staff is also in the process of converting appropriate equipment – mowers - zero turn riding mowers to tracked snow blowers. Staff also removes older Toro GM riding mowers - mowing decks, and replaces them with street sweeping type brushes used for snowy sidewalks. Park staff is mounting sanders to vehicles (pickups, grain body and large dump trucks), and also mounting plows to vehicles, testing hydraulics and making sure all is prepared for when it is needed.

Mr. Fobes also reported that plowing stakes have been placed along our park roads and street drains have been identified with markers. We have moved sand inside facilities or covered outdoor sand piles with tarps. Staff has prepared plow vehicles with winter related items by placing shovels, blankets and ice melt and deicer within. Motorized winter related equipment such as walk behind snow blowers have been tested.

Mr. Fobes reported that staff has placed signage relating to pond or lake ice "Keep Off the Ice" or "No Skating", and making sure all signage is readily available should we have ice skating and ice fishing. Mr. Fobes also reported that if conditions exist we have supervised ice skating at Shark River Park, Holmdel Park, Turkey Swamp Park, Manasquan Reservoir, and unsupervised at Seven Presidents Oceanfront Park, and Ice fishing at the previous areas and Marlu Lake at Thompson Park. Mr. Fobes reported that a continuous temperature of 0 degrees to 30 degrees F is required to produce 4" of ice that is safe for skating, and 5" of ice is necessary for other activities.

Mr. Fobes reported that preparation of the sled hill is complete and noted that all lighting, fencing and signage is in place and ready to go should it be needed this weekend as there is a chance snow in the forecast. MONOC (first aid and ambulance) contract is in place and ready if needed. Holmdel Park is obviously a large scale sledding operation, still receiving a fair amount of attention as is Wolf Hill sledding area and Big Brook.

Mr. Fobes reported that park staff has winterized the waterlines at the Turkey Swamp Campgrounds as well as the Nomoco group camping area. Water fountains and shower towers throughout the Park System have been winterized. The Dorbrook Sprayground is winterized. Irrigation systems, such as Mt. Mitchill's, are winterized. The Marina also has been prepared for the winter months by winterizing water lines, shrink wrapping boats, and placing on racks.

For the Operations Staff, November is a time to finish up with our summer equipment and put it to bed for the winter and prepare for the winter conditions that can show up anytime from this point forward.

Vice Chairman Mandeville noted that he would be interested in seeing park maintenance facilities on the next Board Park Tour.
