Commissioner Hennessy noted a correction to the February 9, 2015 Executive Session Meeting Minutes for the purpose of discussing Land Acquisition Matters.

Commissioner Zelina abstained as not being present at the meeting.

On a motion made by Commissioner Horsnall, seconded by Commissioner Hennessy, the MINUTES of the EXECUTIVE SESSION MEETING of the Monmouth County Board of Recreation Commissioners held on MONDAY EVENING, FEBRUARY 9, 2015, for the purpose of discussing ANTICIPATED LITIGATION ATTORNEY CLIENT PRIVILEGE, were upon being put to a vote, approved as recorded by Chairman Rummel, Vice Chairman Mandeville, Commissioners Harmon, Hennessy, Horsnall and Butch. Commissioner Zelina abstained as not being present at the meeting.

On a motion made by Commissioner Horsnall, seconded by Commissioner Hennessy, the MINUTES of the EXECUTIVE SESSION MEETING of the Monmouth County Board of Recreation Commissioners held on MONDAY EVENING, FEBRUARY 9, 2015, for the purpose of discussing PERSONNEL MATTERS, were upon being put to a vote, unanimously approved as recorded by Chairman Rummel, Vice Chairman Mandeville, Commissioners Harmon, Hennessy, Horsnall and Butch. Commissioner Zelina abstained as not being present at the meeting.

The Secretary-Director indicated that the Minutes of the Executive Session would be made available to the public in ninety (90) days, or upon completion of land acquisition matters, and that the Minutes of the Executive Session for the purpose of discussing Anticipated Litigation Attorney Client Privilege will be available to the public in ninety (90) days, or upon completion of anticipated litigation. The Secretary-Director also indicated that the Minutes of the Executive Session to discuss Personnel Matters shall not be made available to the public, as Personnel Matters are confidential.

On a motion made by Commissioner Horsnall, seconded by Vice Chairman Mandeville, the **2014 VOUCHER LIST**, as submitted for approval, was upon being put to a vote, unanimously approved as recorded.

On a motion made by Commissioner Horsnall, seconded by Vice Chairman Mandeville, the **2015 VOUCHER LIST**, as submitted for approval, was upon being put to a vote, unanimously approved as recorded.

James J. Truncer, Secretary-Director, introduced staff who made the following **Presentations** to the Board:

#### 1. Golf Report

Mike Janoski, County Park Superintendent/Golf Operations, reported that the Golf Courses are covered in snow and ice, and whenever possible, crews have been attempting to remove the ice/snow to prevent any winter damage to the turfgrass. Mr. Janoski noted that it appears the scheduled opening day of March 1<sup>st</sup> will be delayed due to the conditions.

Mr. Janoski reported that the bridge contractor at Howell Park Golf Course has completed the majority of the work on three (3) of the six (6) bridges and will be finishing the fourth (4<sup>th</sup>) bridge in the near future and also noted that all that remains on the completed bridges is to install wood curbing and concrete transitions which will require warmer weather. Mr. Janoski also reported that the replacement of the last two (2) bridges will not begin until after April 1<sup>st</sup> due to permit requirements.

Mike Janoski reported that Monmouth County IT has been in the process of upgrading our IT infrastructure in the golf centers, and that three (3) of the six (6) golf centers have been updated with new firewalls and more network bandwidth. Mr. Janoski also reported that the Golf Administration staff is busy working with our vendor, USeDirect, to install the new Point of Sale and Tee Time System hardware and software upgrades for the coming golf season.

#### 2. Parks Report

Tom Fobes, Superintendent of County Parks/Park Operations, reported on operations requirements relating to storm—snow response and that the goal of parks is to open on time, be safe, clean and clear for available winter recreation opportunities, and that non operations employee areas are to be clean, clear and safe prior to their arrival. Tom Fobes noted staff's response to weather conditions reporting to work at 4 a.m., 5 a.m., and 6 a.m. Tom Fobes noted mechanics brought in to repair equipment as well as support staff (operators) for larger plows and sanders and that sites crew is brought in to operate heavy equipment for snow removal (rubber tired loader, articulated loader, bull dozer, 4 wheel drive sander, larger dump trucks plow or sand), and that Park Rangers are brought in to operate 4-wheel drive pickup trucks with plow, shovel or sweep walkways, de-ice areas, clear patios, clear picnic tables, open up storm drains and then begin detailed work.

Tom Fobes reported on identifying heat issues in facilities at Fort Monmouth, Dorbrook Park Maintenance, the Manasquan Reservoir Environmental Center geothermal, and the Thompson Park Training Center.

Tom Fobes noted that the recently purchased propane heaters at the activity barn provided a comfortable area for the archery program during the single digit temperatures.

Tom Fobes reviewed with the Board frozen pipes challenges at Seven Presidents Activity Center, the Seabrook Wilson House, and the air pressure issue at Portland Place.

Tom Fobes updated the Board in regard to skating, sledding, ice fishing and cross-country skiing opportunities in the parks. Tom Fobes reported that all park areas are open and should continue through the weekend. Tom Fobes noted that Seven Presidents had skaters, and that the Manasquan Reservoir was open for skating and ice fishing and had participants in both. Tom Fobes noted that the average ice thickness system wide, prior to Saturday night's rain, is nine inches. Tom Fobes noted that staff continues to lay down cross country ski trails when conditions exist and that visitors continue to participate.

Tom Fobes reported that thirty-four (34) incident reports were filed in January and February which included motor vehicle related incidents, a juvenile incident of marijuana at Dorbrook Park, and minor skating and sledding injuries.

Tom Fobes reported that the 29<sup>th</sup> Basic Ranger Training Class is underway and will continue through March 6<sup>th</sup>, and noted the various classes being taught by Park System staff.

Tom Fobes also reported that the Policy Academy begins March 9<sup>th</sup> and continues through March 20<sup>th</sup> which includes instructors and classes being taught and concludes with OC exposure (pepper spray).

#### 3. Visitor Services Report

Patti Conroy, Superintendent of Recreation, reported to the Board that Visitor Services is busy creating programs and events; leading programs and organizing events; booking rentals; marketing; public information; recruiting and training volunteers; and organizing the upcoming volunteer reception.

Patti Conroy presented a power point presentation highlighting the following events that Visitor Services plans and organizes or is involved with throughout the year:

- January First ever WinterFest (Jan. 10) with close to 1,700 visitors, organized by Outdoor Adventures;
- March—Half-Marathon (March 1) 480 pre-registered runners, expecting 600-800 runners if weather is good, organized by Sports and Fitness;
- April—Environmental Summit (April 18), Manasquan Reservoir, organized by the Naturalists, Earth Day Celebration (April 26) at the following locations: Huber, Manasquan, Turkey Swamp, Deep Cut Gardens, Thompson Park, Bayshore Waterfront Park, organized by the Naturalists, Spring Plant Swap (April 25), Deep Cut, organized by the Naturalists, and Spring Craft Show (April 25), Tatum Red Hill, organized by Cultural Services;
- May First ever Spring Creative Arts Festival (May 2nd and 3<sup>rd</sup>) Thompson Park, organized by Creative Arts, fine art and music festival, Superhero Fun Run (May 30), Dorbrook Recreation Area, organized by Sports and Fitness;
- June Family Funtathlon (June 6), Thompson Park—like amazing race, Outdoor Adventures and Sports and Fitness organize this event, Eco-Elephant Flea Market (June 20 and August 22), organized by Cultural Services at Dorbrook Recreation Area;

- July Monmouth County Fair (July 22-26);
- August Sweet Corn Festival (August 15), Walnford, organized by Therapeutic Recreation;
- September 911 Ceremony at Mt. Mitchell, organized by Public Information Karen Livingstone, first ever Wind and Sea Festival (September 19), Bayshore Waterfront Park, organized by Nature Interpretation, Outdoor Adventures, and Sports and Fitness;
- October Creatures of the Night Hayrides, Huber Woods, organized by the Naturalists, Timberbrook Triathlon (October 10), Manasquan Reservoir, organized by Sports and Fitness, Eek-o-Fabulous Costume Swap, Thompson Park, organized by Naturalists, Sports and Fitness, Fort Monmouth, Thompson Park Day (October 18), Thompson Park, organized by Visitor Services;
- November Woods Hollow Mt. Bike Race (November 7<sup>th</sup>), Tatum Park, organized by Sports and Fitness; and
- December Student/Instructor Art Show & Sale (December 5 & 6), Creative Arts
  Center, organized by Creative Arts, which has grown in size and has become very
  popular.

James J. Truncer, Secretary-Director, indicated to the Board that there was no **CORRESPONDENCE RECEIVED** for the Board.

On a motion made by Commissioner Hennessy, seconded by Vice Chairman Mandeville, the meeting was **OPENED** to the **HEARING OF THE PUBLIC** at 7:35 PM. Upon being put to a vote, the motion was unanimously carried.

There being no one present who wished to be heard, it was moved by Commissioner Hennessy, seconded by Vice Chairman Mandeville, that the portion of the meeting Open to the **HEARING OF THE PUBLIC** be **CLOSED**, at 7:36 PM.

#### PRESENTATION:

James J. Truncer, Secretary-Director, introduced to the Board Senior Park Naturalists Joe Reynolds and Sam Skinner, who made a PowerPoint presentation to the Board on the wide variety of "Nature Programs" offered by the naturalist staff.

Chairman Rummel thanked Joe Reynolds and Sam Skinner for their presentation.

James J. Truncer, Secretary-Director, then introduced to the Board Joseph Sardonia, Supervising Landscape Architect, who made a PowerPoint presentation to the Board on the proposed "Hominy Hill Golf Course Clubhouse Design".

Vice Chairman Mandeville inquired as to the current cost estimates for the proposed renovations.

Joe Sardonia noted that the estimate is approximately \$6 Million.

Vice Chairman Mandeville noted his concern with problems encountered in past large projects and increases in costs that have been encountered by the Board.

Joe Sardonia reviewed in detail the proposed changes to the 1<sup>st</sup> and 2<sup>nd</sup> floors of the building and the proposed new entrance and ADA access to the 2<sup>nd</sup> floor.

Vice Chairman Mandeville questioned whether the project is worth the cost.

Commissioner Zelina noted that he felt the project will make an under utilized facility available for more uses by the public.

Commissioner Hennessy inquired as to the return on investment.

Commissioner Harmon noted he would like to see the building used for other uses including golf instruction, and asked that a use plan be shared with the Board.

Commissioner Horsnall noted he also would like to see a projection of uses for the building.

Commissioner Butch inquired as to parking lot size and the inclusion of upstairs bathrooms.

Joe Sardonia noted there appears to be adequate on site parking but no room for incorporating upstairs bathrooms.

Commissioner Peters noted the need for event space and suggested at least one (1) upstairs bathroom.

Vice Chairman Mandeville noted the need to accommodate other uses at the golf courses.

Freeholder Burry noted she felt the site can accommodate a variety of uses.

The Secretary-Director noted that staff will put together a building utilization plan for the Board.

At 8:50 PM, Joe Sardonia and Laurie Stoppiello-Marswillo left the meeting.

Freeholder Lillian G. Burry reported that authorization to purchase the Aberdeen-Wilson Associates property will be on the February 26<sup>th</sup> Freeholders Agenda.

Freeholder Burry also noted that Mike Janoski did an excellent job of preparing a report on the proposed sale of alcohol at the golf courses by concessionaires.
