On a motion made by Commissioner Hennessy, seconded by Commissioner Hood, the meeting was **OPENED** to the **HEARING OF THE PUBLIC** at 7:04 PM. Upon being put to a vote, the motion was unanimously carried.

Chairman Rummel recognized Mr. Lester Mallet, Membership Co-Chair, Congregation B'nai Israel, Rumson, NJ, who asked the Board to consider their request in regard to serving wine and beer at their Congregation's picnic scheduled for June 13, 2014, at Seven Presidents Oceanfront Park.

Mr. Mallet noted that the Board had approved having wine at their Congregation's picnic held in 2013 at Seven Presidents Oceanfront Park.

Mr. David Mintzer, of the Eastpointe Condominium Association, addressed the Board and reviewed the history of requests for tree trimming in front of the Eastpointe Condominium building and noted that the Condominium Association would like to renew a relationship with the county in regard to trimming of trees.

Mr. Chris Christy, a resident of the Eastpointe Condominiums, addressed the Board with regard to the Association's interest in having the trees on the slope trimmed as the trees block resident's views who live on the lower floors, and noted that an arborist has advised him that large trees growing on the slope may be toxic to stabilizing the slope.

Commissioner Harmon inquired as to the type of tree that may create a problem.

Mr. Christy noted that he did not have the name.

  - Following a discussion, a <u>motion</u> was introduced by Commissioner Zelina, seconded by Commissioner Loud, Amending the Date of the 67<sup>th</sup> Metropolitan Golf Association/Metlife Public Links Championship, from Tuesday, July 8, 2014, to Thursday, July 10, 2014, to be held at Charleston Springs South Golf Course, with the Park System charging a fee of \$50.00 per golfer and closing the South Course only to the public, as previously approved by Motion of the Board on January 22, 2014. Upon being put to a vote, the motion was unanimously carried.
- 3. Spence Wickham, Chief of Acquisition & Design, reviewed with the Board the background with regard to the request by various residents at the Eastpointe Condominiums for tree and vegetation trimming at Mt. Mitchill Scenic Overlook, and Green Acres position of not approving work on dedicated park lands for the benefit of a private interest.
  - Commissioner Harmon questioned whether improving the view could be provided as part of being a good neighbor, and suggested that staff review the request.
  - Vice Chairman Mandeville suggested that the Board be provided with photos of the site to have a better understanding of the issues.
- 4. Tom Fobes, Superintendent of County Parks/Park Operations, made a PowerPoint presentation to the Board of the impacts on the Henry Hudson Trail as a result of the recent hillside slump next to the trail, at 160 Ocean Boulevard, being the former Grant house property, and also noted the hillside slump that occurred at 126 Ocean Boulevard, Atlantic Highlands, NJ.

Vice Chairman Mandeville questioned whether the county should sue the Borough of Atlantic Highlands with regard to the Borough's steep slope ordinances.

Special County Counsel Michael P. Supko, Jr., suggested that the Board's geotech consultant should also review the Borough's steep slope ordinance. Special County Counsel Supko also noted that the homeowner's insurance company should be contacted before the start of any trail cleanup.

5. Bruce A. Gollnick, Assistant Director, reviewed with the Board the Status of Funded Projects as of April 24, 2014, as distributed to the Board.
