Chairman Rummel read the following Statement of Adequate Public Notice:

"Statement of Adequate Public Notice of Meeting in compliance with the 'Open Public Meetings Act', Laws of the State of NJ, Chapter 231, P.L. 1975. Notice of meeting has been posted, and the Asbury Park Press and other newspapers circulated in Monmouth County, and the County Clerk have been noticed, including date, time and place, as adopted by the Commission at their regular meeting of November 17, 2014, as required by law."

Chairman Rummel led the Board in the salute to the flag and the Pledge of Allegiance and asked for the observance of a moment of silence.

On a motion made by Commissioner Hennessy, seconded by Vice Chairman Mandeville, the MINUTES of the REGULAR MEETING of the Monmouth County Board of Recreation Commissioners held on MONDAY, SEPTEMBER 21, 2015, were upon being put to a vote, unanimously approved as recorded.

On a motion made by Vice Chairman Mandeville, seconded by Commissioner Hennessy, the MINUTES of the EXECUTIVE SESSION MEETING of the Monmouth County Board of Recreation Commissioners held on MONDAY, SEPTEMBER 21, 2015, for the purpose of discussing LAND ACQUISITION MATTERS, were upon being put to a vote, unanimously approved as recorded.

The Assistant Director indicated that the Minutes of the Executive Session would be made available to the public in ninety (90) days, or upon completion of land acquisition matters.

On a motion made by Commissioner Hennessy, seconded by Commissioner Adcock, the **2014 VOUCHER** LIST, as submitted for approval, was upon being put to a vote, unanimously approved as recorded.

On a motion made by Commissioner Harmon, seconded by Vice Chairman Mandeville, the **2015 VOUCHER LIST**, as submitted for approval, was upon being put to a vote, unanimously approved as recorded.

Andrew J. Spears, Assistant Director, introduced staff who made the following **Presentations** to the Board:

1. Golf Report

Mike Janoski, County Park Superintendent/Golf Operations, reviewed changes that have been made to the tee time reservation system in order to improve functionality. He noted that a new feature has been added where golfers can immediately report technical trouble with the system through an e-mail link.

Mr. Janoski showed photos of the recent reconstruction of the 4th green on the Bel-Aire blue course. The green had previously been artificial turf due to heavy tree cover. The in-house project involved the contracted golf architect and staff from various Park System courses. The new hole will open in the spring of 2016 and will greatly enhance the golfing experiences, according to Mr. Janoski.

Mr. Janoski explained the impact that the recent drought has had on the irrigation pond at Howell Park Golf Course. The New Jersey Water Supply Authority has been releasing into Timber Swamp Brook only the minimum amount of water required in their state permit. As a result, there is limited flow into Howell Park Golf Course's irrigation pond. Mr. Janoski noted that Special County Counsel Michael P. Supko, Jr., will be reviewing the current water allocation agreement to see if we can increase water flow in the future.

2. Parks Report

Tom Fobes, Superintendent of County Parks/Park Operations, presented photos of recent special events in the parks. Mr. Fobes reviewed the September 11 Remembrance Ceremony at Mt. Mitchill Scenic Overlook and commented on how well staff from various areas worked together to refurbish the park's landscaping and set up for the event. He noted that many of the staff considers it an honor to be part of the team staging the ceremony.

Freeholder Lillian G. Burry commended Park System staff on the successful September 11 ceremony and noted that she has received much wonderful feedback. Freeholder Burry thanked Assistant Recreation Supervisor Karen Livingstone for her part in organizing the ceremony.

Mr. Fobes reviewed the various activities that were part of the Harvest Home Festival which attracted over 5,000 visitors, at Longstreet Farm, on September 27. Mr. Fobes commented that the Assistant Superintendent did a great job staging the event and coordinating operational needs with the Ranger staff.

Mr. Fobes then reviewed the cross-country running meets that are held each fall at Holmdel Park. The largest of the five meets was held on October 3 with approximately 4,100 runners from 185 schools. The event drew 6,000 spectators.

Chairman Rummel commented that the race was unique in that it was one of only a few outdoor events in the area that was not cancelled due to the nor'easter.

Mr. Fobes went on to review the impacts that the recent drought has had in the parks. He noted that at the Manasquan Reservoir, low water levels caused the access ramps for the boat docks to be too steep and unsafe for visitors, and as a result, boat tours have been suspended. He also noted that the low water exposes a number of tree stumps that become a hazard to watercraft, especially the tour boat.

Mr. Fobes explained the measures that were taken in advance of the recent coastal storm. Although Hurricane Joaquin remained at sea and did not directly impact Monmouth County, a separate coastal storm hit over the weekend. Mr. Fobes said that in the wake of Sandy that the Park System is more prepared than ever to respond to storms. He said the activity of this past week served as a beneficial drill. Mr. Fobes then shared photos of wind surfers in the bay off Bayshore Waterfront Park during the storm.

Commissioner Harmon asked how the newly replenished beaches held up and whether they experienced significant erosion.

Mr. Fobes responded that there was moderate erosion on the north and south ends at Seven Presidents Oceanfront Park.

Vice Chairman Mandeville asked if there was effective communication and coordination with state officials in advance of the weekend storm.

Assistant Director Andrew Spears answered that Park System staff were in regular communication with the County Office of Emergency Management (OEM). Mr. Spears noted that OEM had requested Park System assistance in designating Wolf Hill Recreation Area and the Thompson Park Central Supply warehouse as relief supply distribution centers, should they be needed.

3. Visitor Services Report

Patti Conroy, Superintendent of Recreation, reviewed with the Board the Wind and Sea Festival that was held at Bayshore Waterfront Park on September 19. Mrs. Conroy explained all the activities that were involved with planning the event. She explained the unique challenges related to limited on-site parking. The Belford Ferry Terminal served as a remote parking site with shuttle buses provided. Mrs. Conroy described the event's activities including crafts, food vendors, non-profit information tables, music, water sports, crabbing, seining, kite flying, sand sculpting, and volleyball.

Vice Chairman Mandeville commended Mrs. Conroy on staging an excellent event.

Andrew J. Spears, Assistant Director, reviewed with the Board the following **BOARD CORRESPONDENCE RECEIVED**:

FREEHOLDER'S REPORT:

Freeholder Lillian G. Burry commented on the October 2 visit with staff and members of the Board. Freeholder Burry noted that the building was in particularly good condition, especially the second floor which includes a number of classrooms. Freeholder Burry explained that she was able to include the recommended acquisition of the school on the Freeholder meeting agenda for October 8.

Freeholder Burry commented that Supervising Planner Paul Gleitz had recently submitted the Fort Monmouth Recreation Area for a planning award. Freeholder Burry noted that it looked favorable that the Park System may win this award.

Mr. Spears reviewed the list of active projects and noted that all projects were more or less on schedule. He also noted that work began on reconstructing the Manasquan Reservoir Visitor Center fishing dock, which was damaged by ice flows two winters ago.

Vice Chairman Mandeville reiterated the Board's interest in having an Environmental Center constructed in the western part of the county, perhaps at Perrineville Lake Park. Vice Chairman Mandeville noted that it is time that we start to offer programs in this part of the county.

Assistant Director Andrew Spears noted that Park System staff would discuss the master plan for Perrineville Lake Park and start to place the item on the capital budgeting horizon.

Commissioner Butch agreed that such a center would be very beneficial in this part of the county. She also noted that Perrineville Road, which currently is very close to the lake, could be realigned to provide greater opportunities for access to the lake.

Freeholder Burry mentioned that she had received a copy of Hazlet's Town Council resolution in support of the preservation of Stone Road Meadows. Freeholder Burry noted that the Freeholder Board would likely pass a resolution supporting the project.

Spence Wickham, Chief of Acquisition and Design, explained that he had recommended, via letter to the Hazlet Council, that they apply for municipal open space grant money for the project.

Mr. Coeyman answered that such linkages would not be likely, although the parcel would stand on its own as a regional park for passive recreation, specifically, hiking trails.

Posts and comments shall be courteous and relevant to the Monmouth County Park System. All comments and posts shall be reviewed by the Social Media Coordinator. The Park System may choose not to publish posts or comments. The Park System shall refrain from publishing comments/posts that:

- Contain obscene or indecent language;
- Contain threats or defamatory statements;
- Contain hate speech directed at race, color, sex, sexual orientation, national origin, ethnicity, age, religion or disability;
- Promote or endorse services or products; or
- Promote or endorse ballot issues, candidates for public office or other campaign-related material, or non-county related events and programs.

Users who violate this policy may be banned from having comments posted in the future.

Copyrighted material shall not be posted or submitted in any form unless permission to do so is clearly indicated. In posting comments or other material, a commenter grants the Monmouth County Park System and anyone viewing a Monmouth County Park System social media page permission to copy, distribute, or display the commenter's words or photographs publicly and free-of-charge.

INTRODUCTION

Whereas, the Monmouth County Board of Recreation Commissioners under NJSA Title 40:12-6 shall have full control over lands, playgrounds and recreation places; and

Whereas the Board of Recreation Commissioners authorizes the sale and consumption of alcoholic beverages as provided by the Food and Beverage Concessionaire at Charleston Springs Golf Course, Millstone Township; Hominy Hill Golf Course, Colts Neck Township; Howell Park Golf Course, Howell Township; and Shark River Golf Course, Neptune Township; as a convenience and an amenity to those who patronize these locations.

REGULATION

Whereas this type of contract would be regulated by the New Jersey Division of Alcoholic Beverage Control (NJABC), the concessionaire would be required to apply for a NJABC Special Concessionaire Permit a/k/a Annual State Permit. This state permit is issued to a private vendor who has a contract with a government agency to provide alcoholic beverage services to the public. The concessionaire must apply for a permit at each site and pay the annual fee per site as established by the NJABC.

INSURANCE REQUIREMENTS

The Concessionaire shall be required to provide the following minimum insurance policies in accordance with the recommendation of the County's Insurance Consultant:

- Worker's Compensation and Employer's Liability with limits of \$1,000,000 for each accident and \$1,000,000 each employee and policy limit for disease
- Commercial General Liability with limits of \$1,000,000 each occurrence, \$2,000,000 general aggregate, and \$2,000,000 products
- Liquor Liability Insurance with a minimum limit of liability per occurrence and aggregate of \$2,000,000
- Business Automobile Liability of not less than \$1,000,000 each accident combined for bodily injury and property damage
- The County of Monmouth, Monmouth County Board of Recreation Commissioners, and their respective officers, servants, and agents must be endorsed as additional insureds on the Contractors Commercial General and Liquor Liability policies.

AVAILABILITY

Alcoholic beverages shall only be sold and/or consumed during the normal operating times of the golf courses listed above unless a special event approved by the Secretary-Director or his/her designee dictates extended hours. Alcoholic beverages shall be available seven days a week throughout the concessionaire's contractual period. During normal operating hours, the concessionaire shall be limited to dispensing malt alcoholic beverages on the golf course proper and shall be limited to dispensing malt alcoholic beverages and wine within buildings. For golf course outings and other approved special events not open to the public, the concessionaire shall be able to negotiate their services directly with the outing/special event organizers and/or participants. In the event a tent or other golf course building is utilized for these types of events, the concessionaire shall be able to dispense all types of alcoholic beverages as allowed by the NJABC regulations.

CONCESSIONAIRE'S EXCLUSIVE RIGHTS

Concessionaire at the above mentioned county owned golf courses shall have the exclusive right to sell food and beverages (including alcoholic beverages) at the golf courses on a daily basis as well as for golf outings and/or approved special events. Concessionaire shall be granted these exclusive rights only after submitting a formal bid and being awarded a contract as reviewed and approved by County Counsel.
