RESOLUTION CREATING AND APPOINTING MEMBERS TO
THE BUDGET ADVISORY GROUP

WHEREAS, the Board of Chosen Freeholders of the County of Monmouth are committed to fiscal responsibility and responsible action to ensure County residents receive efficient, effective and excellent quality services such as libraries, public safety, parks and code enforcement from Monmouth County government; and
