

**RESOLUTION AUTHORIZING THE  
MONMOUTH COUNTY BOARD OF CHOSEN FREEHOLDERS  
TO ADOPT THE 2010-2012 MONMOUTH COUNTY COMPREHENSIVE ALCOHOLISM  
AND DRUG ABUSE PLAN**

**WHEREAS**, the County of Monmouth is in receipt of a letter from Ms. Suzanne Borys, New Jersey State Department of Human Services, Division of Addiction Services, dated May 12, 2009 which approved the draft “2010-2012 Monmouth County Comprehensive Alcoholism and Drug Abuse Plan”; and

**WHEREAS**, the Board of Chosen Freeholders approved resolution #09-945 authorizing the Director to execute an application for contract funds with the New Jersey Department of Human Services to support services during 2010 outlined in the “2010-2012 Monmouth County Comprehensive Alcoholism and Drug Abuse Plan”; and

**WHEREAS**, the overall total funding needed to implement the “2010-2012 Monmouth County Comprehensive Alcoholism and Drug Abuse Plan” during 2010 is \$1,246,104.00 and County funds will be provided in the 2010 Budget to fulfill the local share in the amount of \$148,195.00; and

**WHEREAS**, the County of Monmouth is in receipt of a letter from Mr. Jose Gonzalez, New Jersey Department of Human Services, Division of Addiction Services, dated November 17, 2009 which approved use of \$1,097,909.00 in State funds to support services described in the “2010-2012 Monmouth County Comprehensive Alcoholism and Drug Abuse Plan” during the period January 1, 2010 through December 31, 2010; and

**WHEREAS**, the Monmouth County Board of Alcohol and Drug Abuse Services has recommended to the Board of Chosen Freeholders the “2010-2012 Monmouth County Comprehensive Alcoholism and Drug Abuse Plan” which consists of 96 pages outlining projects, plans and programs for addressing alcoholism and drug abuse in Monmouth County; and

**WHEREAS**, the Monmouth County Board of Chosen Freeholders desires to support, approve and adopt the “2010-2012 Monmouth County Comprehensive Alcoholism and Drug Abuse Plan” and desires to expend concomitant contract monies from the State of New Jersey to provide these necessary and desirable services.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Chosen Freeholders of the County of Monmouth that the “2010 Monmouth County Comprehensive Alcoholism and Drug Abuse Plan” be and the same is hereby approved and adopted.

**BE IT FURTHER RESOLVED**, that the Clerk of the Board of Chosen Freeholders of the County of Monmouth forward three certified true copies of this resolution with attachments to the Director of the Monmouth County Division of Mental Health and Addiction Services: Office of Addiction Services for transmittal to the New Jersey Department of Human Services, Division of Addiction Services and other required entities.
