MINUTES OF THE MONDAY EVENING, DECEMBER 5, 2016 REGULAR MEETING OF THE MONMOUTH COUNTY BOARD OF RECREATION COMMISSIONERS HELD IN THE "BEECH ROOM" OF THE THOMPSON PARK VISITOR CENTER, 1ST FLOOR, 805 NEWMAN SPRINGS ROAD, LINCROFT, NJ.

Chairman Rummel read the following Statement of Adequate Public Notice:

"Statement of Adequate Public Notice of Meeting in compliance with the 'Open Public Meetings Act', Laws of the State of NJ, Chapter 231, P.L. 1975. Notice of meeting has been posted, and the Asbury Park Press and other newspapers circulated in Monmouth County, and the County Clerk have been noticed, including date, time and place, as adopted by the Commission at their regular meeting of November 23, 2015, as required by law."

Chairman Rummel led the Board in the salute to the flag and the Pledge of Allegiance and asked for the observance of a moment of silence. On a motion made by Commissioner Peters, seconded by Commissioner Adcock, the MINUTES of the REGULAR MEETING of the Monmouth County Board of Recreation Commissioners held on MONDAY EVENING, NOVEMBER 21, 2016, were upon being put to a vote, approved as recorded by Chairman Rummel, Commissioners Harmon, Peters, Butch and Adcock. Commissioner Horsnall abstained as not being present at the meeting.

On a motion made by Commissioner Harmon, seconded by Commissioner Adcock, the **2015 VOUCHER** LIST, as submitted for approval, was upon being put to a vote, unanimously approved as recorded.

On a motion made by Commissioner Harmon, seconded by Commissioner Adcock, the **2016 VOUCHER LIST**, as submitted for approval, was upon being put to a vote, unanimously approved as recorded.

James J. Truncer, Secretary-Director, indicated to the Board that there was no **CORRESPONDENCE RECEIVED** for the Board.

On a motion made by Commissioner Horsnall, seconded by Commissioner Peters, the meeting was **OPENED** to the **HEARING OF THE PUBLIC** at 7:04 PM. Upon being put to a vote, the motion was unanimously carried.

Chairman Rummel recognized Mr. Vince Lepore, of Long Branch, NJ.

Mr. Vince Lepore inquired about the award of a contract to Perez-Casado Enterprises, Inc., t/a MAACO Tinton Falls, Tinton Falls, NJ, for Furnishing and Delivery of Auto Body Repair Service (Bid #0018-17), in the estimated total contract amount of \$25,000.00, as listed on the Agenda as Item #23.

James J. Truncer, Secretary-Director, noted the contract is a 2017 estimate of vehicle body and fender repairs.

Mr. Lepore also inquired as to the availability and use of State Green Acre and Blue Acre Funds to acquire public access sites to the northern beaches in Sea Bright.

James J. Truncer, Secretary-Director, noted the State Green Acres Program and County Open Space Plan and that it is his understanding that the County is not eligible for Blue Acre Funds.

Commissioner Harmon reported on his conversation with the Sea Bright Borough Administrator and that the Administrator noted that the Borough has limited staff and that Rutgers and the Monmouth Conservation Foundation may be able to assist the Borough.

At 7:12 PM, Vice Chairman Mandeville arrived at the meeting.

Commissioner Harmon reviewed his discussions with several property owners in Sea Bright as to sites for possible public beach access.

There being no one else present to be heard, it was moved by Commissioner Horsnall, seconded by Vice Chairman Mandeville, that the portion of the meeting **OPEN** to the **HEARING OF THE PUBLIC** be **CLOSED**, at 7:17 PM.

James J. Truncer, Secretary-Director, introduced staff who made the following **Presentations** to the Board:

1. <u>Visitor Services Report</u>

Patti Conroy, Superintendent of Recreation, reviewed with the Board the Visitor Services Report of December 2016, and noted the <u>2016 Summer Camp Inclusion Survey Results</u> which survey included:

- Types of camps attended;
- · Services provided;
- Accommodation meetings beneficial; and
- Was inclusion a success.

Patti Conroy shared the following additional comments with the Board as to why they felt inclusion was successful:

- "My son wouldn't be able to attend camp without these services....I cannot even begin to describe how happy we are with these services."
- "Staff is wonderful, very kind and considerate."
- "My son really felt supported by his inclusion coach...His struggle with transitions greatly decreased..."
- "All the coaches and staff are amazing, they always tried to include my son as much as possible."
- "My son finds it difficult to make friends and initiate play with others. His inclusion coach gave him just enough support to feel comfortable without being excluded from the group and by the end of the week of the week he was talking to all of the other kids."
- "I like that children are able to participate in a 'regular' camp but have support in case of difficulties. As a parent I feel more secure that my child will have a positive experience. Being with typical peers is so beneficial to her."
- "I have been extremely impressed with the supervisory staff and the front-line Inclusion Coaches. Everyone has been very communicative and responsive to me and my child always with empathy and in a timely manner! Thank you!"
- "Beyond satisfied with all of my children's experiences with the Monmouth County Park System. Excellent staff, programs, and experiences provided to ALL of my children."
- "Thank you so much for everything. If not for these camps, my child would have nowhere to go."
- "I can't say enough good things about Monmouth County Parks! Justin is always so helpful great staff from top to bottom!"

Patti Conroy also reviewed with the Board the Annual Programmer's Meeting held in the Fall and noted that all programmers including operations and golf attended. Patti Conroy shared with the Board a video recapping 2016 at the Monmouth County Park System that was shown at the programmer's meeting.

2. Golf Report

Mike Janoski, County Park Superintendent/Golf Operations, reported to the Board on what a wonderful job our employees have done this past season in maintaining our golf courses and providing our customers with great experiences. Mr. Janoski also reported to the Board that he thinks it speaks volumes that golfers are continually saying how much they enjoy the courses and what wonderful shape they are in.

Mr. Janoski noted that we continue to strive to improve conditions and reported to the Board that staff recently completed renovations on the blue tee of the 2nd hole at Shark River Golf Course and have now begun working on a similar renovation on the 5th hole. Mr. Janoski reported that these renovations include leveling, expanding and improving the soils of existing tees as we look forward to installing the new irrigation system this winter. Mr. Janoski also reported that bids are due tomorrow for the irrigation system, and that our engineering firm has also begun surveying work for the irrigation pond there as well.

Mr. Janoski reported that all of the irrigation systems and pump houses have now been winterized and put to bed until next season and the bulk of the labor lately has been going to leaf cleanup, which most of the leaves, thankfully, are down now. Mr. Janoski reported that next we will begin to overhaul equipment, perform our preventative maintenance, and prepare the golf course for harsher winter conditions.

Mr. Janoski reported that we look forward to the Polar Bear Tournament again this winter which is scheduled for January 14th, and hopefully, the snow will hold off once again for us.

Mr. Janoski also reported that rounds are still going pretty strong through November and noted that we had another 12,500 rounds for the month which is down a bit from last year's number of 13,400 but still up significantly over 2014 when we did just over 8,300 rounds, and year to date, we continue to be up. Mr. Janoski reported that we reached the 210,000 round mark in November and are still up almost 4,000 rounds for the year as compared to 2015. Mr. Janoski reported that in 2014, we had only done 197,000 rounds so all in all things are going very well for the golf courses.

3. Parks Report

Tom Fobes, Superintendent of County Parks/Park Operations, updated the Board with regard to park operations during the month of November.

Mr. Fobes provided the Board with a brief description of Deer Management and noted that Category 1 is for Archery only, and that the season generally runs from October 1 through the end of January or mid-February, and state bag limits (how many deer a hunter may take) apply.

Mr. Fobes also noted that hunters are required to submit a harvest log at the end of the season and reported that he will not have harvest numbers until late March or early April.

Mr. Fobes noted that Category 2 is taking place now in three (3) parks. The park is closed to the visiting public until 12 noon, and then opened once all hunting has ceased.

Mr. Fobes briefly described the Rut – both males (bucks) and females (does).

Tom Fobes reviewed with the Board the process of choosing hunting dates for Category 2 – the Rut, and noted other considerations including park use—still nice weather (we turn away daily users – ½ day), cross country, available hunters in an area, holidays, and Ranger staffing.

Mr. Fobes reported to the Board on the following harvest report, as of today, and noted that we are about one-half way through our Category 2 season:

Area 407 - Holmdel Park:

- 11/16: 9 hunters, 3 deer (0 antlered /1 antlerless male /2 female), 126 visitors
- 11/18: 10 hunters, 3 deer (2/1/0), 150 visitors
- 11/22: 4 hunters, 0 deer, 61 visitors
- 11/29: 2 hunters, 0 deer, NA (requested update)
- So far 6 deer harvested, 2 dates remaining 12-13 and 16

Area 411 – Thompson Park:

- 12/1: 12 hunters, 3 deer (0/2/1), 81 visitors
- 12/5: 19 hunters, 8 deer (1/1/6), 23 visitors
- So far 11 deer harvested, 3 dates remaining 12 7, 9 + 15

Area 417 – Hartshorne Woods Park:

- 11/30: 6 hunters, 2 deer (0/1/1), 27 visitors
- 12/2: 5 hunters, 0 deer, NA(will get update tomorrow when Ryan is back in)
- So far 2 deer harvested, 3 dates remaining 12 6, 8 + 14

Freeholder Burry noted the deer culling program currently underway at Fort Monmouth, by FMERA.

Tom Fobes reported to the Board on Freneau Woods Park and noted the recent closing on Saint Basils. Mr. Fobes reported that Rick Royle, Sr. Park Manager, has been assigned to the park, and that he is very much gung hoe and moving forward with clean up. Mr. Fobes noted that it was an exciting time and that we are underway with the following:

- We have cleaned up leaves and mowed the entire St. Basils property;
- Replaced approximately 60 lock sets or cores;
- Began removing debris from inside buildings and have already emptied three (3) 30-yard dumpsters;
- Focused on the Church, Assumption Hall and two (2) small houses, and have repaired eight (8) glass doors;
- In the process of building three (3) large wooden park gates;
- Beckers Tree Company is working on dead and or dying trees and removing stags;
- In the kitchen of Assumption Hall, we have begun organizing various canned foods that have not expired and arranged for pickup with the Food Bank of Monmouth;
- Began boxing plates, glasses, silverware, pots and pans;
- Converted the utilities over to us and have had inspections of our propane tanks, heating and air conditioning systems, and security systems; and
- Scheduled dates with the long time plumber that worked on St. Basils and our plumbers to go over various issues we may encounter.

Tom Fobes, Superintendent of County Parks/Park Operations, reviewed with the Board the Union Transportation Trail (UTT) and a shooting range on Wygant Road. Mr. Fobes reported that Wygant Road is in Upper Freehold Township, a relatively short road (1 mile) with approximately 14 houses of which most are farms. The road lies between Jonathan Holmes Road and Burlington Path Road. Wygant Road somewhat parallels the UTT, although the road and trail are a distance apart. Mr. Fobes noted that a resident of Wygant Road that owns a large tract of land checked with the Township regarding holding a Turkey Shoot (target shoot) on or about Thanksgiving, and the resident built an earthen mound and planned on shooting The resident had created a shooting range. Mr. Fobes noted that the UTT is approximately 400 yards behind the mound. Mr. Fobes also noted that since there was no ordinance in place preventing the shoot, the resident was able to do so. Other residents have come forward against the shooting range and have stated concerns regarding the safety of UTT users, and as a side note, some have mentioned a concern with hunting on private property adjacent to the trail. Mr. Fobes reported that there was a Town Council Meeting this past Thursday, December 1st, and approximately 7-10 residents expressed their concerns regarding the shooting range. Mr. Fobes indicated that he wanted to make the Board aware of this issue and will update the Board should things change or if anything is asked of us.

FREEHOLDER'S REPORT:

Freeholder Lillian G. Burry noted the proposed opening of the "Avenue of Memories" through Fort Monmouth as an extension of County Route #537 and that a condition of opening the road is the reduction of the deer population at the Fort.
