MINUTES OF THE MONDAY EVENING, JANUARY 9, 2017 ANNUAL FIRST REGULAR MEETING OF THE MONMOUTH COUNTY BOARD OF RECREATION COMMISSIONERS HELD IN THE "BEECH ROOM" OF THE THOMPSON PARK VISITOR CENTER, 1ST FLOOR, 805 NEWMAN SPRINGS ROAD, LINCROFT, NJ.

The meeting was called to order by Chairman Fred J. Rummel at 7:04 PM.

Chairman Rummel read the following Statement of Adequate Public Notice:

On a motion made by Commissioner Horsnall, seconded by Commissioner Adcock, the MINUTES of the REGULAR MEETING of the Monmouth County Board of Recreation Commissioners held on MONDAY EVENING, DECEMBER 19, 2016, were upon being put to a vote, approved as recorded by Commissioners Harmon, Hennessy, Horsnall and Adcock. Chairman Rummel, Commissioner Peters and Commissioner Butch abstained as not being present at the meeting.

On a motion made by Commissioner Horsnall, seconded by Commissioner Adcock, the MINUTES of the EXECUTIVE SESSION MEETING of the Monmouth County Board of Recreation Commissioners held on MONDAY EVENING, DECEMBER 19, 2016, were upon being put to a vote, approved as recorded by Commissioners Harmon, Hennessy, Horsnall and Adcock. Chairman Rummel, Commissioner Peters and Commissioner Butch abstained as not being present at the meeting.

Fred J. Rummel indicated that this was the time and place of the Board's Annual First Regular Meeting for the purpose of considering **NOMINATIONS FOR OFFICERS** for the **YEAR 2017**.

On a motion made by Commissioner Hennessy, seconded by Commissioner Peters, it was <u>moved</u> that the **SECRETARY-DIRECTOR** of the Board be **APPOINTED** as **TEMPORARY CHAIRMAN** of the **MEETING**. Upon being put to a vote, the motion was unanimously carried.

On a motion made by Commissioner Horsnall, seconded by Commissioner Adcock, it was <u>moved</u> that **FRED J. RUMMEL** be **NOMINATED** for the position of **CHAIRMAN** of the Board. The Secretary-Director asked if there were any other nominations from the floor. There being none, on a motion made by Commissioner Hennessy, seconded by Commissioner Butch, the nominations were, by unanimous vote, closed.

On a motion made by Commissioner Horsnall, seconded by Commissioner Peters, it was <u>moved</u> that the Secretary-Director of the Board cast one ballot for the nominee for **CHAIRMAN** of the Board. Upon being put to a vote, the motion was unanimously carried.

The Secretary-Director cast one ballot in favor of the nominee, FRED J. RUMMEL, for CHAIRMAN of the Board.

On a motion made by Commissioner Harmon, seconded by Commissioner Horsnall, it was <u>moved</u> that **KEVIN MANDEVILLE** be **NOMINATED** for the position of **VICE CHAIRMAN** of the Board. The Secretary-Director asked if there were any other nominations from the floor. There being none, on a motion made by Commissioner Hennessy, seconded by Commissioner Harmon, the nominations were, by unanimous vote, closed.

On a <u>motion</u> made by Commissioner Horsnall, seconded by Commissioner Harmon, it was <u>moved</u> that the Secretary-Director of the Board cast one ballot for the nominee for **VICE CHAIRMAN** of the Board. Upon being put to a vote, the motion was unanimously carried.

The Secretary-Director cast one ballot in favor of the nominee, **KEVIN MANDEVILLE**, for **VICE CHAIRMAN** of the Board.

The Secretary-Director announced that MR. FRED J. RUMMEL was duly elected to the position of CHAIRMAN, and that MR. KEVIN MANDEVILLE was duly elected to the position of VICE CHAIRMAN for the YEAR 2017.

On a motion made by Commissioner Hennessy, seconded by Commissioner Adcock, the **2016 VOUCHER LIST**, as submitted for approval, was upon being put to a vote, unanimously approved as recorded.

On a motion made by Commissioner Hennessy, seconded by Commissioner Adcock, the **2017 VOUCHER LIST**, as submitted for approval, was upon being put to a vote, unanimously approved as recorded.

James J. Truncer, Secretary-Director, indicated to the Board that there was no **CORRESPONDENCE RECEIVED** for the Board.

On a motion made by Commissioner Horsnall, seconded by Commissioner Butch, the meeting was **OPENED** to the **HEARING OF THE PUBLIC** at 7:10 PM. Upon being put to a vote, the motion was unanimously carried.

There being no one present to be heard, it was moved by Commissioner Hennessy, seconded by Commissioner Butch, that the portion of the meeting Open to the **HEARING OF THE PUBLIC** be **CLOSED**, at 7:11 PM.

At 7:12 PM, Vice Chairman Mandeville arrived at the meeting.

James J. Truncer, Secretary-Director, introduced staff who made the following **Presentations** to the Board:

1. <u>Visitor Services Report</u>

Patti Conroy, Superintendent of Recreation, reviewed with the Board Visitor Services highlights from 2016 and reported that Visitor Services' revenue of \$2,902,125.23 is up \$240,357.52.

Mrs. Conroy reported to the Board on <u>Nature Interpretation</u> and noted revenue of \$228,749.57 is down \$7,062.48. Mrs. Conroy also reported that Joe Reynolds is working with students at Marine Academy of Science and Technology (MAST), at Sandy Hook, on two projects being the Children's Garden Design for Deep Cut Gardens, and a Wildlife Blind Design for the Clay Pit Creek section of Hartshorne Woods. Mrs. Conroy reported that Area 302 South ran two new group programs in 2016 being Operation Conservation, and Habitat Study.

Mrs. Conroy reported to the Board on <u>Cultural Services</u> and noted revenue of \$347,948.22 is up \$59,851.14. Mrs. Conroy also reported that Programming in the Thompson Park Theater Barn is growing, and that patrons and instructors enjoy the unique setting in which we host a myriad of performing art programs & camps. Mrs. Conroy reported that the Eco-Elephant Flea Market had record attendance in June 2016 of over 100 vendors. Mrs. Conroy also reported on our Community Outreach and noted that we make catnip toys out of orphan socks and have consistently made over 60 per season with the toys being donated to local cat shelters which have been well received. Mrs. Conroy noted that this year's recipient was Rescue Ridge from Spring Lake, NJ. Mrs. Conroy also reported that the Spring & Fall Craft Show reached record numbers for vendors at 37 and 55.

Mrs. Conroy reported to the Board on <u>Urban Recreation</u> and noted revenue of \$18,048.75 is down \$9,752.25. Mrs. Conroy also reported to the Board on the 36 Monmouth University Scholarships valued at \$8,850.00 and the 31 Friends of the Parks Scholarships valued at \$6,655.00. Mrs. Conroy reported that there were 242 Holiday Party participants, and 24 Coastal Activity Center participants.

Mrs. Conroy reported to the Board on <u>Creative Arts</u> and noted revenue of \$485,407.39 was up \$37,470.05. Mrs. Conroy also reported that the Student/Instructor Show and Sale once again was greeted with a line of people waiting to enter the exhibit. Attendance was estimated at 700 guests, and with 115 students and 15 instructors participating, they made approximately \$16,000.00. Mrs. Conroy reported that out of 33 camps, 30 sold out, and that Shark week was the new big hit of the summer with Clay and Fine Arts camps continuing to be popular. Mrs. Conroy reported that Pottery is well over capacity and most pottery classes were oversold by 2-3 students. Mrs. Conroy reported that even if we wanted to add more classes we would not be able to keep up with the firing demands.

Mrs. Conroy reported to the Board on Therapeutic Recreation and noted revenue of \$176,866.50 is up \$11,713.20. Mrs. Conroy reported that Senior Hikers had 963 total registrations in 2016. This includes the five (5) hike days throughout the year and the two (2) special hikes in the spring and two (2) in the fall. Due to the program's overwhelming popularity, two (2) supplemental hikes for Level 1 and Level 2 hikers were added for Tuesdays and Fridays respectively in the spring and fall with a maximum of 20 hikers each with one (1) hike leader. This has helped alleviate the huge waitlists. Mrs. Conroy reported that there were 168 therapeutic campers this year between Recreation Challenge, Adult Adventures, Summer Capers and Capers Quest. Mrs. Conroy reported on the Semi-Formal Dinner and Dance and noted that there were 45 participants which event was sponsored by Friends of the Parks. Mrs. Conroy reported that the Monmouth County Recreation Activity Center (MCRAC) program is at its highest total participant enrollment in years with 25 total participants between the 3 days. Mrs. Conroy reported that the Night Out/ weekend programming for teens and adults has become extremely popular in the last year, with four (4) programs in the fall being sold out and three (3) of them overbooked with the securing of additional program staff. Mrs. Conroy noted that Inclusion is as big as ever, and that we had 44 participants which were served with Inclusion Coaches over the course of the 2016 camp/ swim season for a total of 2190 service hours and that five (5) participants for a total of nine (9) swim lessons with Inclusion staff. Mrs. Conroy reported that an ASL interpreter provided for two (2) parent and me swim classes. Mrs. Conroy also reported that ten (10) individual participants were served with Inclusion Coaches for non-camp/non-swim programs throughout 2016. Mrs. Conroy reported that there were twenty-one (21) different programs for a total of 116 service hours.

Mrs. Conroy reported to the Board on Equestrian and noted revenue of \$263,581.82 is up \$27,202.94. Mrs. Conroy also reported that the SPUR program consisted of about 3,600 individual lessons throughout the year, and that a total of 220 volunteers participated in the SPUR program in 2016. Mrs. Conroy reported that over 120 new volunteers joined the SPUR program this year, and they held five volunteer workshops. Mrs. Conroy reported that the Equine Environment for Learning program continues to grow with the addition of the Long Branch School System and the Central Regional School District to the Collier School Group. Mrs. Conroy reported that the Therapy horse "Steady" received the 2016 Isaac's Perpetual Trophy for Therapy Horse of the Year at the HRH Show, and that the Therapy horse "Diesel" was awarded Smart Pak's PATH Horse of the Month for November, which also featured a

spotlight on our Horses for Heroes Program. Mrs. Conroy reported that SPUR hosted multiple Veterans' Workshops through our Horses for Heroes program, and noted that multiple Veterans who attended our Horses for Heroes Equine Psychology Series are now part of the volunteer base. We are very proud to see the transformation from program participant to volunteer for these Veterans, which is a major goal of the Horses for Heroes program. Mrs. Conroy noted that we hosted 72 additional programs specifically for Community Outreach. Mrs. Conroy reported on Fundraising and noted \$19,493.00 was raised, and another very generous donation of \$10,000.00 was received from an anonymous local celebrity and his family to purchase new therapy horses. Mrs. Conroy reported that PATH awarded us a \$4,000.00 grant to conduct a study in collaboration with Rutgers University on measuring the physiological indicators of stress and well-being in humans and horses, and that there was a successful partnership between Dr. Malinowski of Rutgers and the MCPS Equestrian Division. Mrs. Conroy reported that Students from Red Bank Catholic raised \$1,243.00 for the SPUR program through their "Dress Down Day" at school.

Mrs. Conroy reported to the Board on <u>Outdoor Adventures</u> and noted revenue of \$220,765.11 is up \$4,282.30. Mrs. Conroy also reported that there were 76 sailboat drop-ins at the Reservoir resulting in \$3,385.00 in revenue, which is up slightly from 2015, and 521 cross country ski and snowshoe rentals. Mrs. Conroy reported that all hiking programs filled, both locally and travel trips. Mrs. Conroy also reported that Scuba, Twilight Biking and Paws on the Trail were new programs that were added.

Mrs. Conroy reported to the Board on Sports & Fitness and noted revenue of \$716,336.88 is down \$82,916.19 (Area 343-soccer \$60,000, decrease in revenue camps). Mrs. Conroy also reported on: 1) Programs: Sports & Fitness had 639 programs, birthday parties, and special events, serving 5,865 participants; 2) Camps: 123 camps ran with 1,681 participants; 3) Swim Lessons: 212 swim lessons with 925 participants; 4) E. Murray Todd Half Marathon had 768 registrants, an increase from 2015 which had 722 registrants; 5) Super Hero Fun Run has reached its max at 185 registrants, a slight increase from 2015's 181 registrants; and 6) Volleyball and tennis continues to grow.

Mrs. Conroy reported to the Board on the Fort Monmouth Recreation Area and noted revenue of \$417,494.50 is up \$197,730.57. Mrs. Conroy reported that soccer was up \$60,000, revenue for Camps was up almost double, and pickleball and swimming was up. Mrs. Conroy also reported that there were 99 new program numbers offered at Fort Monmouth. Mrs. Conroy reported on the successful new program areas which included Cooking Classes, Junior Counselors, Martial Arts, Home Design, and One-Time Family Programs. Mrs. Conroy also reported on Community Outreach—Tinton Falls Day, Eatontown Day, Tinton Falls PTA, and talking to our guests throughout the year.

Mrs. Conroy reported to the Board on the <u>Fort Monmouth Pool</u> and noted that 2016 was the second summer there was open public swim time at the Fort. Mrs. Conroy reported that Total Pool Attendance for the Open Public Swim was 5,840, and that there were 26 RAP Groups that varied in size from 15-50 participants. Mrs. Conroy reported on the following Pool Passes Sold: 34 Season Family; 3 Season Individual; 7 Monthly Family (June); 62 Monthly Family (July), 55 Monthly Family (August); 0 Monthly Individual (June); 8 Monthly Individual (July); and 9 Monthly Individual (August).

Mrs. Conroy also reported to the Board on <u>Birthday Parties</u> and noted that there were 65 parties with a total of 3,299 patrons. She also reported on <u>Gym rentals</u> and noted that there were 12 - one hour rentals; 52 - two hour rentals; 10 - three hour rentals; 3 - 1 hour, ½ gym rentals; 11 - 2 hour, ½ gym rentals; for a total of 2,506 patrons. Mrs. Conroy reported that the total Drop-In Patrons served was 2,936, and that there were 2,620 Facility Visitors.

Mrs. Conroy also reported on <u>Volunteers</u> and noted that there were a Total of 992 Volunteers providing 22,035.36 Volunteer Hours.

Mrs. Conroy reported on Marketing and Communications and reported there were 5,143 Green Link mailings; 40,289 Green Heritage mailings; 139,441 Parks & Program Guide mailings; 49,920 Parks & Programs Guide postcard mailings; and 48,900 Events mailings. She also reported that email blasts go out 55 times a year to 24,460 email addresses, and noted that the Golf Shots email goes out 16 times to 16,523 email addresses. Mrs. Conroy also reported that we received 2,476 emails and 25 wildlife emails, and that the Information Desk received 7,043 phone calls. Mrs. Conroy also reported that there were 8,900 Visitors at the Thompson Park Visitor Center.

Mrs. Conroy reported on the website and noted that there were 3,063,089 page views; 996,332 visits; and 561,185 unique visitors. Mrs. Conroy also reported on Social Media and noted that there were 13,592 Facebook followers, 1,514 Twitter followers, 66,330 Blog views, and 1,101 Instagram followers.

Mrs. Conroy reported to the Board that Thompson Park Day had a record attendance of 14,218 visitors.

2. Golf Report

Mike Janoski, County Park Superintendent/Golf Operations, reported that, at the moment we're facing a bit of snow delay. We just had to postpone the Polar Bear Tournament scheduled for this Saturday and we're going to attempt to run it on the following Saturday January 21st. Mr. Janoski also reported that we're busy preparing our equipment for next season and doing all the necessary preventative maintenance in our facilities. We're also compiling all of our 2016 statistics that we will share with the Board in the coming weeks. Mr. Janoski also reported that December was a bit of a slow month for us due to the weather but probably more typical to what we can usually expect. We had a couple nice days around Christmas and New Year's but otherwise rounds were significantly down when compared the 2015 in which we had a spectacular month doing over 9,000 rounds. For this past month, we registered a little over 3,500 rounds and finished the year at just under 214,000 rounds of golf. Mr. Janoski reported that right now we're focused on preparing for the irrigation system installation scheduled for this winter at Shark River. Mr. Janoski reported that one interesting thing to note is that the chain TopGolf just opened a new facility in Edison, and they describe themselves as the premier golf entertainment complex. Mr. Janoski reported that it is a driving range set up with dartboard-like targets in the ground that you hit microchipped golf balls into to score points.

3. Parks Report

Tom Fobes, Superintendent of County Parks/Park Operations, updated the Board with regard to park operations. Mr. Fobes reported that the end of November and all of December is a time to prepare for the winter. Equipment is prepared, plowing stakes installed, ice skating and ice rescue equipment put in place and sled riding hills prepared. The Toro zero turn Polar Trac system, an addition to our maintenance fleet this past season, has become a valuable part of our snow cleanup process. Mr. Fobes also reported that the past weekend's snow storm provided plenty of visitor opportunity for winter recreation. Mr. Fobes described the process of preparing Holmdel Park and the Sled hill after a storm, as follows:

- Staff plowed snow until Midnight Saturday night, returning at 6:00 AM to continue.
- While plowing the roads and parking lots, clearing the sidewalks, staff also is preparing the sled hill.
- Truck with plow and sander is backed up the hill, snow plowing back down the hill and spreading sand, providing visitors a safe walkway.
- The bottom of the hill is plowed and sanded so that sled riders speed is reduced and stopped.
- Signage is placed designating age restricted areas and reinforcing rules.
- MonOc ambulance service is placed and available to assist Rangers should there be injuries.
- Should the hill develop moguls or large bumps, a bull dozer is brought in to smooth the surface.
- Once the hill is open to the public, Rangers are strategically placed on the hill and walkway, moving visitors along, preventing collisions.
- Staff is placed along roadways and parking lots, directing vehicle traffic.

Tom Fobes reported that Holmdel Park Attendance for Saturday January 7th, 2017, was minimal during the actual snow storm. Staff remained on site to well after dark, nearly midmight, returned at 6:00 AM Sunday, so that we could be prepared for the expected large crowd. Park visitor attendance on Sunday, January 8th was 3,863. We did not have to close the park due to overcrowding.

The Cross Country Skiing Hut was opened on Sunday January 8th, 2017, following Saturday's Storm. Park Manager Dan Bisti was able to groom approximately 10 miles of trails. One hundred forty three (143) park visitors rented cross country skis and seventeen (17) visitors rented snow shoes. Many visitors owning their personal skis visited Thompson Park as well, enjoying the groomed trails. Wolf Hill Recreation Area also had a nice crowd of park visitors on Sunday. The smaller hill, popular with younger users, hosted approximately 900 visitors.

Tom Fobes reported that although it was and is cold, the weekend storm, our facilities and staff, provided a nice opportunity for visitors to experience winter recreation.

FREEHOLDER'S REPORT:

Freeholder Director Lillian G. Burry inquired as to closings at Fort Monmouth Recreation Area.

Michael P. Supko, Jr., Special County Counsel, noted the F-3 Parcel is in the process and the Recreation Center parcel will close soon.

BE IT FURTHER RESOLVED that in the event the entire property is not used to compensate for potential disposals or diversions of County public open space by the end of the term of an agreement for that purpose between the County of Monmouth and the State of New Jersey Green Acres Program, the Division of Engineering shall be reimbursed for the unused portion from the Monmouth County Open Space, Recreation, Floodplain Protection, Farmland and Historic Preservation Trust Fund, Account #T-12-56-850-115-667 at the per acre price paid to acquire the property; and
