Vice Chairman Mandeville read the following Statement of Adequate Public Notice:

“Statement of Adequate Public Notice of Meeting in compliance with the ‘Open Public Meetings Act’, Laws of the State of NJ, Chapter 231, P.L. 1975. Notice of meeting has been posted, and the Asbury Park Press and other newspapers circulated in Monmouth County, and the County Clerk have been noticed, including date, time and place, as adopted by the Commission at their regular meeting of November 20, 2017, as required by law.”

Vice Chairman Mandeville led the Board in the salute to the flag and the Pledge of Allegiance and asked for the observance of a moment of silence.

On a motion made by Commissioner Harmon, seconded by Commissioner Horsnall, the **MINUTES** of the **REGULAR MEETING** of the Monmouth County Board of Recreation Commissioners held on **MONDAY EVENING, MAY 21, 2018**, were upon being put to a vote, unanimously approved as recorded.

On a motion made by Commissioner Horsnall, seconded by Commissioner Adcock, the **2017 VOUCHER LIST**, as submitted for approval, was upon being put to a vote, unanimously approved as recorded.

On a motion made by Commissioner Horsnall, seconded by Commissioner Adcock, the **2018 VOUCHER LIST**, as submitted for approval, was upon being put to a vote, unanimously approved as recorded.

James J. Truncer, Secretary-Director, indicated to the Board that there was no **CORRESPONDENCE RECEIVED** for the Board.

On a motion made by Commissioner Horsnall, seconded by Commissioner Adcock, the meeting was **OPENED** to the **HEARING OF THE PUBLIC** at 7:09 PM. Upon being put to a vote, the motion was unanimously carried.

Vice Chairman Mandeville noted a limit of three (3) minutes for each speaker and Commissioner Harmon thanked those who were present from Atlantic Highlands, and thanked Benson Chiles.

Vice Chairman Mandeville recognized Mr. Benson Chiles.

Mr. Chiles addressed the Board and thanked the Board for the Board’s leadership in the county’s open space. He also thanked County Freeholder Deputy Director Burry and James Truncer for their leadership. Mr. Chiles noted that the citizens of Atlantic Highlands supported the 2017 increase in the County Open Space Tax by 66%. Mr. Chiles noted the location of the McConnell property and the importance of the site as a park and the importance of the property in providing small boat access to the bay. Mr. Chiles also noted the current uses of the site including boat storage and that a real opportunity for future public use exists and that the current owner is McConnell Realty Trust.

Mr. Chiles submitted to the Board written comments.

Arthur Sorensen noted the importance of providing easy access to the water along with other sites along the bay. This site could be Atlantic Highlands' contribution, and made the following comments:

- I've lived and worked in or near Atlantic Highlands for 76 years "All my life?" not yet;
- Public Access – Atlantic Highlands people walk. Public transport – Bus line on Center Avenue;
- Private next door on Harbor View Drive – example of blocking both view and access; and
- Link from Port Monmouth Belford waterfront, Hudson Trail, Activity Center Route 36, and Popamora Point!

Matt Goushy noted his organization teaches sailing to children and that the site has easy access to the water and is a safe location for learning to sail and noted the property is important.

Dido Krikorian noted it is the only property in Atlantic Highlands with access to the water with a beach, and that is also important for the local economy.

Commissioner Zelina asked what is the position of the Borough of Atlantic Highlands.

Paul Eidman noted he is a fishing guide and the importance of preserving natural shorelines for fish reproduction. He noted the importance of the site and the sailing program.

Cory Wingerter noted he feels the site needs to be preserved much like Chris' Landing that the county is currently creating as a passive park. Mr. Wingerter noted that he is here today to speak about the preservation of the 7 acre waterfront McConnell tract located in Atlantic Highlands, NJ. Mr. Wingerter presented a written memo to the Board dated June 11, 2018.

Bob Jopson noted the site is adjacent to the water with outstanding views of Sandy Hook and the New York Skylands.

Jim Krauss noted Atlantic Highlands has a history of preserving open space and establishing a municipal open space tax, and he did not want the last piece of land and the waterfront lost.

Vic Simon commented on the Catamaran Club and noted the club uses the adjacent property under a long term lease and that the Catamaran Club is the largest in the United States. Mr. Simon also noted if the property is not preserved there will be lack of youth sailing opportunities. Mr. Simon noted that the site could be used by other park users from the county.

Andrew Chiles noted he is 11 years old and he likes to sail and fish and the McConnell property would be safer than the pier.

Kathy Butler noted it was a great place for kids to learn to sail.

Don Adler noted that he moved to Middletown from Massachusetts because of the County Park System and the county parks provide a benefit to all citizens. Mr. Adler also noted the site is a great place for the public to meet and interact for countywide programs and facilities and events, and that acquisition of that site will help provide superior recreational facilities. Mr. Adler noted the purposes of the Park System and read a quote from the Park System 50 Year History Book.

Benson Chiles, Jr., noted he is part of the youth sailing program.

Gloria Seidel noted that the view from the site is beautiful with unique views.

Cory Wingerter, Jr., noted he moved to Atlantic Highlands because of the waterfront and the great views.

Millie Alsup noted she teaches in the youth sailing program and its importance to serving youth.

Brent Sonnek-Schmetz noted the site could become a national sailing center.

Lori Hohenleitner noted the site will be a benefit as an equalizer and the town's economy will benefit with access from the Henry Hudson Trail and help build the community.

Steve Zink noted the Monmouth County Park System's 50 Year History.

Len Fantasia noted changes to Atlantic Highlands and the need for water access and that people want access.

Lisa Chiles noted the site provides a safe place to feed the ducks.

Kevin Busick noted people are looking for access to the water.

Mrs. Erin Drew noted her children have been a part of the sailing program and that the site could also provide a place for seniors to view the bay.

Melody Quirk, a life time resident of Monmouth County, noted the need to provide a sailing experience for children in the future.

Peter Shearer noted as a member of the Catamaran Club, members patronize and support local businesses.

Kate Wingerter noted she visits the site and supports preserving it for the public.

Holy Snedeker noted the sailing program gets kids outside.

Dawn McCahon noted that the Girl Scouts have, over the years, been active in cleaning the beach.

Suzanne Santry, Vice Chairman of the Atlantic Highlands Board of Education, noted the need to incorporate the school curriculum with the water.

Vice Chairman Mandeville introduced Freeholder Deputy Director Burry who noted the request is exceptional; however, the Freeholder noted she would like to hear from the governing body of the municipality.

Commissioner Horsnall noted the excellent presentations and thanked those present.

Commissioner Hennessy also thanked those present for their presentations.

Commissioner Harmon noted that issues in the Borough had arisen in the past and the need for political will to complete such an acquisition and that in his opinion the development of housing on the site as proposed will result in conflicts with the current uses.

Vice Chairman Mandeville noted what he had experienced growing up in Matawan and the loss of open space.

Commissioner Adcock noted his involvement in a sailing program and that he is an advocate for youth sailing programs.

There being no one else present who wished to be heard, it was moved by Commissioner Horsnall, seconded by Commissioner Hennessy, that the portion of the meeting **OPEN** to the **HEARING OF THE PUBLIC** be **CLOSED**, at 8:20 PM.

At 8:20 PM, Vice Chairman Mandeville declared a recess.

The public left the meeting.

At 8:35 PM, Vice Chairman Mandeville called the meeting to order.

SECRETARY-DIRECTOR'S REPORT:

James J. Truncer, Secretary-Director, introduced staff who made the following **Presentations** to the Board:

1. **Visitor Services Report**

Patti Conroy, Superintendent of Recreation, reported to the Board on how Visitor Services is doing, and what Visitor Services is working on, as follows:

- Revenue is up \$96,991.25 from last year – \$1,658,048.25;
- Swim lessons, open swim, boat tours are underway;
- Preparing for summer camps—completing hiring and summer staff training;
- Summer camps start next week;
- Volunteers—trail team at Huber Woods;
- Held the Clayton Park Open House—38 visitors;
- Held the Creative Arts and Music Festival. Mrs. Conroy noted that what makes this event unique is the many activities for children to do as well as purchase artwork and listen to music—2,500 visitors;
- Saltwater Fishing Derby at Bayshore—low turnout;
- SPUR horse show;
- Deep Cut Open House—150 Visitors;
- Master Gardeners also gave out our extra tomatoes and basil which thrilled the visitors;
- Bonsai Society came out in force and worked on the collection while they were here;
- Deep Cut Orchid Society;
- Mid Atlantic Carnivorous Plant group;
- Central Jersey Beekeepers; and the
- Iris Society.

2. **Golf Report**

Mike Janoski, County Park Superintendent/Golf Operations, updated the Board and displayed pictures of recent flooding at Pine Brook, Hominy Hill, and Charleston Springs Golf Courses; displayed a picture of recent debris removal by the Bridge Department at the entrance to Howell Park Golf Courses; displayed a picture of an in-house project to construct an artificial wetland at Howell Park to capture water from the wash pad area. Mr. Janoski also reported to the Board that, despite the weather, golf rounds in May were actually up over 1,000 rounds versus that same month in 2017.

3. **Parks Report**

Tom Fobes, Superintendent of County Parks/Park Operations, updated the Board with regard to park operations during the months of April through May.

Mr. Fobes reported to the Board that incident reports are filed by Park Staff documenting a wide variety of situations that arise on Park System Property. System wide, staff will complete approximately 500 incident reports per year. During 2017, 517 reports were filed through the Superintendent's office.

Mr. Fobes also reported to the Board that May and April's attendance were relatively low due to weather, however, even when parks are slow the Park Rangers are still faced with a variety of situations and must be prepared to handle whatever they are presented with, and handle the situation professionally and effectively.

Mr. Fobes reported to the Board that April and May this year were similar to past years as to the types of incidents, and noted the following examples of incident reports submitted which included:

Injuries: falls, exhaustions, heart ailments, cuts, broken bones, bruises, head bumps, neck injuries, so on and so forth, Dog bites, dog on dog and dog on people, vehicles in parks after hours, motor vehicle accidents, deer hit by motor vehicle, falls from horses, loose horses, horse nips, motorcycles or 4-wheelers on park property, bikes in the skate park, brush fires, graffiti, Hunting issues – still finding tree stands, littering and alcohol issues.

The following are examples of somewhat unique incidents, although not unusual, that Park Rangers responded to and handled professionally and effectively:

- Fishing hook in child's hand – Turkey Swamp Park;
- Heat exhaustion – Sunnyside Equestrian Center;
- Hypodermic needles in port-a-john – Crosswicks Creek;
- Break-in, Park building – Freneau Woods;
- Motor vehicle accident – Shark River Park;
- Missing person – Hartshorne Woods;
- Abandoned tractor – Clayton Park;
- Pole fire – Shark River Park;
- Fawn caught in fence – Thompson Park;
- Vehicle stuck on beach – Seven Presidents Oceanfront Park;
- Intoxicated individual – Henry Hudson Trail; and
- Pig wrangling – Crosswicks Creek.

FREEHOLDER'S REPORT:

Freeholder Deputy Director Lillian G. Burry noted that the Board of Chosen Freeholders will recognize July as "Parks & Recreation Month", and the Opening Ceremony for "Battery Lewis", at Hartshorne Woods, is scheduled for Saturday, June 16th, at 10 AM.
