ORDINANCE NO. 1-2013 AN ORDINANCE REVISING CHAPTER 130, LAND USE, ARTICLE II, DEFINITIONS and WORD USAGES **SECTION 130-5 DEFINITIONS** OF THE CODE OF THE BOROUGH OF SEA BRIGHT

WHEREAS on October 29, 2012 the Borough of Sea Bright suffered extreme devastation as a consequence of Superstorm Sandy; and

WHEREAS as a consequence of the devastation caused by Superstorm Sandy structures throughout the Borough were either destroyed or severely damaged; and

WHEREAS as part of the process of recovery from Superstorm Sandy the Mayor and Council of the Borough of Sea Bright has begun an effort to ensure its Borough Zoning Ordinances are clear and concise so as to aid residents and businesses in restoring their properties; and

WHEREAS in furtherance of the aforesaid effort the Mayor and Council of the Borough of Sea Bright have determined it will be necessary to clarify certain definitions within its zoning ordinance;

BE IT NOW ORDAINED, by the Mayor and Council of the Borough of Sea Bright that Chapter 130, Article II, Definitions and Word Usages, Section 130-5, <u>Definitions</u>, shall be amended as follows:

Section 130-5 shall be revised as follows:

(1) The existing definition of the term "Building" shall be redefined as follows:

A combination of materials to form a construction adapted to permanent, temporary continuous occupancy and having a roof. Decks, patios or raised platforms without roofs over 18 inches above grade shall be considered as part of the building and must comply with all building setback association with a swimming club use and considered a "Seasonal requirements. Any structure used in shall not be considered a "Building." Structure"

The following definition of the term "Seasonal Structure" shall be added: (2)

Any structure which lacks one or more basic amenities or utilities required for year round occupancy or use such as a permanent heating system, insulation and/or year round usable plumbing. Height and bulk be applicable to all Seasonal Structures. requirements for accessory structures shall

BE IT FURTHER ORDAINED all other sections of Chapter 130 shall remain in full force and effect. In the event there is any conflict or inconsistency between this particular ordinance and the rest of Chapter 130, the terms in this ordinance shall prevail.

This ordinance shall take effect upon passage and publication as required by law.
