TARIFF SCHEDULE AND REGULATIONS (Effective November 1, 2016)

- SOLID WASTE IS NOT ACCEPTED FROM OUT-OF-COUNTY ROUTES
- TARPS ARE REQUIRED FOR ALL OPEN LOADS (enforced by police)
- ASBESTOS ACCEPTED BY APPOINTMENT ONLY (Wednesdays & Saturdays)
- TIRES MAY NOT BE MIXED WITH OTHER MATERIALS (added surcharge)
- ALL VEHICLES CHARGED ON ACTUAL TONNAGE OR PART THEREOF

DUMPING PERMITS are not required for any car or truck with a gross vehicle registered weight (GVRW) of 9,000 pounds or less, or 16,000 pounds combined maximum GVRW for a vehicle pulling a trailer, which is dumping personal waste. All others, including vehicles less than 9,000 pounds that are hauling others' waste must secure a State DEP permit before dumping. **THE LANDFILL CANNOT SELL YOU THIS NJ STATE PERMIT!** Applications for "self-generators" are available from the County Solid Waste Enforcement Office at the Reclamation Center (732-683-8686 Ext. 5658). State Police investigation (A-901) is required for those collecting/disposing of others' waste (additional fees and waiting period involved). General hauler registration questions may be directed to Roxanne Feasel of the NJDEP at 609-341-5475.

STATE TAXES collected by the landfill include a Landfill Contingency Tax (\$.50/ton), Closure Escrow Tax (\$1.00/ton), NJ Recycling Tax (\$3.00/ton) and a Host Community Tax (\$6.60/ton), paid to Tinton Falls.

PROHIBITED RECYCLABLES include: NEWSPAPER, GLASS/ALUMINUM/TIN & PLASTIC FOOD & BEVERAGE CONTAINERS, LEAVES AND GRASS CLIPPINGS, CLEAN MIXED PAPER AND CORRUGATED CARDBOARD. CAR PARTS, BATTERIES AND APPLIANCES are not accepted. Also prohibited is CONCRETE, ASPHALT (except shingles), TREE STUMPS AND LARGE TREE PARTS (over 3" diameter). However, carloads may include small amounts of these last four bulky items. The landfill does not accept any liquids or hazardous wastes. Since January 1, 2011, COMPUTERS AND TELEVISIONS are no longer accepted for disposal, pursuant to the NJ Electronic Waste Management Act.

GRASS CLIPPINGS are accepted separate from other wastes @ \$3.00 per car or \$36.50 per ton for trucks. Station Wagons, Minivans and SUV-type vehicles qualify for the car rate only when all grass is behind the rear-most seat. **CASH PAYMENTS** are accepted only from cars or small trucks dumping personal waste. Commercial customers must establish a pre-paid account with the Reclamation Center (call MCRC Scale Office @ 732-683-8686 Ext. 5600) – mail address 6000 Asbury Avenue, Tinton Falls, NJ 07753 – attention: MCRC Payments). Government customers may contact the County Finance Department @ 732-431-7391 Ext. 7454 (Hall of Records, 1 East Main Street, Freehold, NJ). Delinquent accounts may not dump.

ATTENTION RESIDENTS! Residents needing to dispose of household paints (Oil Base, Enamel, Spray Paint) or chemicals can dispose of these household hazardous wastes at the Monmouth County Household Hazardous Waste (HHW) Facility. **Latex paint is not HHW (Please dry it out and remove lid and dispose with your regular household trash).** Call 732-683-8686 Ext. 5210 for address and hours.
