11. The purpose/goal is to stop family abuse and decrease violent behavior choices, generate awareness of said behaviors, and promote the development of alternative behaviors.

- h. Exploring one's values and beliefs
- i. Address distortions of thought – criminal thinking vs. responsible thinking
- j. Address issues of choice, responsibility, and consequences/

Mercy Center is a community-based, comprehensive social services agency with programs offering free services without discrimination. Facilitators often inform inmates of the relevant services available and how to access those services and resources for their families or upon their release. Inmates' families in our communities receive food from Mercy Center's Food Pantry, help with SNAP food assistance enrollment or renewal, and emergency assistance (housing and utility aid) to alleviate some of the financial burdens their families might be experiencing.

The families may also access support counseling from Mercy Center's Family Resource Center and services for victims and survivors from our Community Victim Advocacy program. Inmates' families also receive Thanksgiving baskets and Christmas presents for their children. Most importantly, when released, inmates can follow up at the Family Resource Center for counseling or continue with makeup classes to complete anger management or parenting curriculum to receive the certificate.
