Our Fees and Billing

We understand that efficiency in all aspects of operations is important to you. Our proposal fees reflect our engagement strategy to provide quality performance in a timely and cost-efficient manner. After careful review of the property listing and requested scope, we designed a five-year program that appraises all properties with an estimated cost exceeding \$1 million in 2023, all properties with an estimated cost between \$500,000 and \$1 million in 2024, and budgets for onsite valuations as needed in 2025 through 2027. The makeup of the valuation for 2005-2007 is at County's discretion and can consist of newly acquired or recently renovated buildings, properties under \$500,000, and reappraisals. This program is our estimate to meet the needs outlined in the RFP in a cost-efficient manner. If the County decides a different approach (i.e., valuation of 20% of the portfolio per year) is more appropriate we will accommodate at the same relative cost. Our fees are inclusive of travel are based on the estimated time necessary to render such services at the related professional's hourly rate.
