Tetra Tech, Inc. The following four pages summarize Tetra Tech, Inc.'s (Tetra Tech's) qualifications to provide New Jersey Licensed Site Remediation Professional (LSRP) environmental consulting services as identified in the Request for Qualifications (RFQ) for On-Call LSRP Services at Various Monmouth County Locations.

COMPANY OVERVIEW

Tetra Tech is a leading provider of consulting and engineering services. 1. **OUR LSRPs:** Tetra Tech's LSRPs have the practical experience and demonstrated track record to streamline the site closure process by capitalizing on years of experience with NJDEP requirements combined with an understanding of when professional judgment is appropriate to achieve site closure objectives. Our LSRPs have, in other cases, taken previous NJDEP decisions to the NJDEP Technical Consultation committees for review and successfully convinced NJDEP to allow our client to discontinue expensive long-term remedies (e.g., such as pumping and treating groundwater).
