A. Reading the Results

Various statistics regarding health status, education, mortality, crime, employment, and others have been collected to portray the current status of Monmouth County residents. For all of the data provided, the most recent published data at the county or municipality level were used. For example, if 2010 data are available at the national and state level, but only 2009 data is available at the county level, year 2009 data are utilized.

Definitions

Age-Adjustment - There are characteristics that may at times render a crude rate of little use, especially when comparing different populations. Therefore, age-adjusted rates offer a more refined measurement to compare experiences over geographic areas or periods of time.

Crude Rates - Generally defined as the total number of events divided by the total population at risk; then multiplied by 1,000, 10,000, or 100,000.

Incidence Rates - Rates per 100,000 population for the specified years.







The population within Monmouth County increased by 4.7% from 2000 to 2009, this is below the 9.1% population increase across the country, but is above the 3.5% population increase in New Jersey. The median age within Monmouth County is 41.0 years with 41.6% of the population between the ages of 25 and 54. The population of the elderly (65 and over) grew by .5% in the United States, .3% in New Jersey and .9% in Monmouth County from 2000 to 2009. Monmouth County is comprised of 85.4% White residents. This is above the percentage of White residents across both New Jersey and the United States.





In Monmouth County there are fewer females that are head of the household with no husband present (9.7%) compared to New Jersey (12.7%) and the United States (12.4%). The percentage of renter-occupied homes in Monmouth County (23.7%) is much lower than in New Jersey (32.9%) and throughout the nation (33.1%). The average family size is similar for the United States, New Jersey, and Monmouth County.

The marriage rate in Monmouth County is similar to the rate in New Jersey, but below the national rate. The divorce rate in Monmouth County (2.6) is below the state (2.9) and national divorce rate (3.6).



The median household income in Monmouth County (\$82,013) is much higher than New Jersey and the nation. Similarly, the percentage of individuals in poverty in Monmouth County is lower than New Jersey and the nation. Asbury Park City is the school district with the highest percentage of children in poverty (30.5%) followed by Keansburg Borough and Freehold Borough at 19.8% each.


In 2009, the amount of children receiving welfare in Monmouth County showed a slight decrease (10%) from 2006; conversely, children receiving food stamps increased by a large amount (21%) from 2005 to 2009. There was an 8.4% increase from '04-'05 to '08-'09 in the amount of children receiving free or reduced lunch.

The unemployment rate in Monmouth County (4.1%) is lower than the unemployment rate in New Jersey (4.6%) and the United States (4.7%). The top employer in Monmouth County is Meridian Health Systems followed by U.S. Army Communications and the County of Monmouth. Fewer people in Monmouth County walked to work (2.6%) than in New Jersey (3.3%) and the United States (2.9%).

The mean travel time to work in Monmouth County is 33.0 minutes. This is above the mean travel time in New Jersey (29.6 minutes) and the United States (25.2 minutes). In Monmouth County, the production, transportation, and material moving occupations comprise a smaller percentage of the workforce compared to New Jersey (10.2%) and the nation (12.5%).







Cerebrovascular Disease



Chronic Lower Respiratory Disease




Similar to the United States and New Jersey, Heart Disease is the leading cause of death in Monmouth County. Followed by Heart Disease is Cancer. Monmouth County had a slightly higher rate of deaths due to cancer than the U.S. and New Jersey. Within the county, Middletown Township had the highest number of deaths due to heart disease, malignant neoplasms, cerebrovascular disease and chronic lower respiratory diseases (2006).



Infant mortality rates in Monmouth County (4.7) are slightly below the rates statewide (5.3). Additionally, the infant mortality rate in 2006 for Monmouth County is just above the Healthy People 2010 goal (4.5). Not only are the infant mortality rates below the state rates, but the rate of deaths under age 15 in Monmouth County is notably lower than the state rate.

H1: Blood Cholesterol Checked in the Past Five Years



H2: Percent of Adults Who Are Overweight and Obese







In 2009, New Jersey saw a decrease in Early Latent Syphilis with 14 less cases from 2008. New Jersey also saw a decrease in Late and Late Latent Syphilis (94 fewer) cases from 2008 to 2009. There were 21 less Gonorrhea cases in Monmouth County between 2008 and 2009. New Jersey saw a sharp increase in Chlamydia cases (1569) from 2008-2009. Cases of Tuberculoses have decreased in New Jersey and Monmouth County in 2009.

As of December 31, 2009, the cumulative AIDS cases in New Jersey were at 53,420, with 2,579 of those cases in Monmouth County. The black community made up the largest proportion of people living with HIV/AIDS in New Jersey (54.0%) and Monmouth County (46.0%). The largest percentage of those living with AIDS/HIV was 45-54 years of age in both New Jersey and Monmouth County. As of December 31, 2009 there are 1,667 persons in Monmouth County living with AIDS/HIV.

In 2009 there were 409 cases of Lyme disease in Monmouth County and 4,973 cases in New Jersey. Monmouth County saw a large increase in cases of Lyme disease from 2007-2008 (241 more cases) but had 112 fewer cases reported in 2009.




Monmouth County Total Invasive Cancer Cases by Gender












In 2004, there were 2,730 reported cases of childhood abuse/neglect in Monmouth County. The large majority of the reported and substantiated cases were Neglect and Physical Abuse in both Monmouth County and New Jersey. Monmouth County had a higher percentage of Neglect cases reported (58.9%) than New Jersey (54.8%). Monmouth County saw a total of 18.0% of cases substantiated. Asbury Park and Keansburg Borough had the most reported neglect/abuse cases.




M1. Adults who have had any permanent teeth extracted

M3. Visited the dentist or dental clinic within the past year for any reason





Total arrests involving domestic violence restraining orders saw a 20% increase in Monmouth County between 2006 and 2007. 



There were a total of 104,829 enrollments in the 2009-2010 school year in Monmouth County. There were 179 dropouts during the 2008-2009 school year with the majority of dropouts being white males. Long Branch City accounted for 24.0% of the dropouts. There were 7,696 graduates in Monmouth County during the 2008-2009 school year. According to the 2008-2009 data, Rumson-Fair Haven Regional, Manasquan Borough, Holmdel Twp, and Monmouth Co. Vocational were the schools which had 70% or more of their graduates planning to attend a 4 year college. Neptune Township had the most students (9.6%) plan to enroll in the Military after graduation in 2008-2009.

In 2009, High Technology High School had an average SAT score of 2060, ranked number 3 out of 329 in the state, and was the top ranked school in Monmouth County. This is followed by Marine Academy of Science & Tech that was the twelfth highest ranked school in the state and Holmdel H.S. that ranked number fifteen in the state.



T. Conclusions

The following conclusions are based on both comparisons to the New Jersey and National data. Areas where Monmouth County fares “worse” than New Jersey and/or the nation are termed “opportunities.” Areas where Monmouth County fares “better” than New Jersey and/or the nation are termed “strengths.” The strengths and opportunities listed below are not intended to be an exclusive list, as some data points are open to debate as to whether it is a strength or opportunity. For example, a higher percentage of arrests for a particular crime could either mean that that particular crime is occurring more or that law enforcement is doing a better job of cracking down on that type of illegal behavior. These areas are listed as areas of difference, as it is not clear whether they are a strength or opportunity.

Areas of Strength

- **Female householder, no husband present**
 - Monmouth County has 9.7% of homes where a female is head of the household and no husband is present. This is smaller than both the state (12.7%) and the rest of the country (12.4%).
- **Occupied/vacant housing units**
 - There is a similar amount of vacant housing units in Monmouth County and New Jersey (9.3% and 9.7% respectively), but both are below the national percentage (11.8%).
- **Divorce Rate**
 - The divorce rate in Monmouth County is 2.6, compared to the New Jersey rate of 2.9 and the national rate of 3.4.
- **Income**
 - The Median Household income in Monmouth County is higher than both the state and nation.
 - The Median Family Income in Monmouth County is also higher than the state and nation as well.
 - Monmouth County also has a smaller percentage of families and individuals in poverty than New Jersey and the nation.
- **Unemployment**
 - The unemployment rate in Monmouth County was a lower percentage (8.5%) than New Jersey (9.2%) and the United States (9.3%).
- **Infant mortality rates**
 - The infant mortality rate for Monmouth County (4.7) is below the statewide rate (5.3).
- **Infant deaths due to preterm/LBW**
 - The rate of infant deaths caused by preterm deliveries or low birth weight is notably lower than New Jersey and the nation. (*Monmouth County: 35.6, New Jersey: 105.6, US: 114.5*).
- **Deaths under age 15**
 - The death rate for children under 15 in Monmouth County is 35.9, compared to 46.6 statewide.
- **Cholesterol Screening**
 - More residents within Monmouth County have had their blood cholesterol checked (88.5%) compared to New Jersey (85.0%) and U.S. residents (80.8%).
 - The percentage of the population in Monmouth County that has never had their blood cholesterol checked (11.5%) is much smaller than New Jersey (15.0%) and the U.S. (19.2%).

➤ **Reported cases of Gonorrhea**

- Since 2007, Monmouth County has seen a steady drop in the reported gonorrhea. In 2007 there were 166 cases compared to 2009 which only had 105 cases.

➤ **Prostate Cancer death rate**

- In 2006, the prostate cancer death rate in Monmouth County (16.3) was well below the Healthy People 2010 objective (28.8).

➤ **Teen births**

- The birth rate among teens age 15-19 within Monmouth County is below the state and national rate. (*Monmouth County: 14.7, New Jersey: 24.5, US: 41.6*).

➤ **Late/no prenatal care**

- 71.7% of mothers in Monmouth County received adequate prenatal care compared to 63.2% of mothers in New Jersey. Similarly, 17.6% of mothers received intermediate prenatal care compared to 20.2% in New Jersey.
- In 2007, the percentage of live births with late or no prenatal care in Monmouth County (3.0%) was lower than the percentages for both New Jersey (4.7%) and the United States (3.9%).

➤ **Marital status of mothers**

- In 2006, 69.4% of the births in Monmouth County were to married mothers, compared to 64.7% throughout New Jersey.

➤ **Oral Health**

- The percentage of adults age 65+ who have all of their teeth removed for any reason is smaller in Monmouth County (14.7%) compared to New Jersey (17.2%) and the United States (18.5%).
- A larger portion of the population in Monmouth County reported that they visited the dentist in the past year than in New Jersey and the nation.

➤ **Violent crime rate**

- The overall crime rate in Monmouth County is below the rate statewide.

➤ **Substance abuse treatment in county**

- About 78% of the substance abuse admissions among Monmouth County residents were admissions into a facility within the county. This is 15% higher than the percentage statewide who are treated in their county of residence.

➤ **Student SAT scores**

- High Technology H.S. ranked first in the county and third in the state in total SAT score average.
- 9 schools within Monmouth County rated in the top 25% across the state.

Areas of Opportunity

- **Commuting to work**
 - Monmouth County workers have longer commutes than the average employee in New Jersey and the nation and are more likely to drive alone to work rather than carpool or take public transportation.
- **Death Rates**
 - The age-adjusted death rates for the white population is higher in Monmouth County (752.1) than New Jersey (736.9).
- **Reported Primary and Secondary Syphilis Cases**
 - Monmouth County saw a rise from 2008-2009 while New Jersey saw a decrease.
- **Reported Chlamydia**
 - From 2007-2008 Monmouth County had 74 less cases of Chlamydia reported but from 2008-2009 there was an increase of 65 cases.
- **Cancer**
 - The overall cancer crude rate across all sites of cancer for Monmouth County is 551.1 which is lower than New Jersey's crude all sites combined rate of 539.0.
 - The incidence rates for **skin cancer** and **breast cancer** within Monmouth County exceed New Jersey's rates.
- **Childhood asthma**
 - The number of both normal admissions to the hospital and through the ER due to childhood asthma increased in Monmouth County from '04-'05, while the rest of the state saw a decrease in admissions.
- **Total Arrests-all ages**
 - In looking at the arrests within Monmouth County in 2008, Monmouth County had proportionally more arrests for both "offenses against family and children" and "liquor laws" compared to the proportions statewide. (*Monmouth County: 7.3% and 4.4%, New Jersey: 3.8% and 2.0%*).
- **SAT Test Results**
 - Out of the 377 schools in New Jersey ranked for their SAT average scores, Asbury Park H.S. ranked 376.
- **Alcohol Consumption**
 - Monmouth County has a larger percentage of adults who are "heavy drinkers" (6.3%) than Edison (3.9%) and New Jersey (5.0%).
 - Monmouth County also has a larger percentage of adults who are "binge drinkers" (15.9%) than Edison (12.4%) and New Jersey (14.0%).

Areas of Difference

➤ **Population by Race**

- The white population in Monmouth County (85.4%) is a larger proportion of the total population when compared to New Jersey (75.8%) and the nation (79.6%).
- Conversely, the black population in Monmouth County (7.9%) is a smaller proportion of the total population than New Jersey (14.5%) and the nation (12.9%)

➤ **Housing Tenure**

- In Monmouth County, of the occupied housing units, 76.3% are owner occupied, while the other 23.7% are renter occupied. The state and national proportions are notably different for owner occupied units (67.1% and 66.9% respectively) and the same is true for renter occupied (32.9% for the state and 33.1% for the nation).

➤ **Children receiving TANF/AFDC, Food Stamps, and Free or Reduced Lunch**

- Monmouth County saw a 10% drop in the amount of children receiving welfare from 2006 to 2009, but saw an increase in both Food stamps and Free or reduced lunch during a similar time frame.

➤ **AIDS/HIV**

- The percentage of white persons living with AIDS in Monmouth County (39.0%) is much larger than the proportion of white persons living with AIDS in New Jersey (22.0%).
- Conversely, the percentage of those living with AIDS that are non Hispanic blacks or Hispanics in Monmouth County was lower than in New Jersey.

➤ **Birth Rates by Maternal Age**

- When compared to New Jersey and the United States, Monmouth County has a higher rate of births to mothers over the age of 30.

➤ **Children Receiving Medicaid**

- The percentage of children receiving Medicaid for both Monmouth County and New Jersey decreased from '08-'09.

➤ **Domestic Violence**

- From 2006 to 2007, there was a 20% increase in arrests involving domestic violence restraining orders in Monmouth County.

➤ **Total arrests-year comparisons**

- From 2007-2008, Monmouth County had an increase in total arrests of 2.7%.
