Dear Lloyd:

Will you please endeavor to obtain the following lots for the Borough, that is lots 67/69/71/155/156 in Block 77.

Lots 73 and 75 in this block are already owned by the Borough.

I am enclosing herewith a copy of voucher No. 549 dated Dec. 29, 1955, paid to Mr. Longstreet for 1955 taxes, however since then he has paid 1956 and 1957 taxes on the lots.

According to Borough records Lot 67 is listed in the name of John Doe and no one pays the taxes on the lot. Lots 69/71/155/156 are in the name of Theodore O. Longstreet who pays the taxes. Mr. Green says Mr. Longstreet bid in a tax title Lien certificate on these lots and pays the taxes.

Mr. Green also says that Emma M. Hause does not own lot 65 as shown in our records, although she pays the taxes on same. I can't remember if she is mixed up with the John Doe lot on her right (lot No. 67) or the Thomas Laws lot on the left (lot 63) but Mr. Green says they are mixed up and we do not have the proper lots according to records in Freehold.

Our records show owner unknown on lot 67 and of course no bills go out and no taxes are being paid.

We get lots 73/75 by deed from Alice G. Robinson, widow, Jan. 18, 1947 in book 2106 pages 437 etc and it was done by you.
