Mr. Schafer moved, seconded by Mr. Jorgensen that the board recommend that borough land is not to be leased to any group for club house. At the present time only youth recreational groups are to use the borough public land. Motion carried all voting "Yes", Secretary was instructed to so notify Mr. William Coulter.

1. That black top be installed in the parking area from Union Avenue to South Street.
2. That borough give some consideration to rezoning and to lease water front property.
3. That the matter of an agreement with Mrs. Messick be concluded.

Meeting adjourned.


